

AGREEMENT NO. 2200

(Amendment # 4 to Short-form Agreement No. 5959-2017-PUMPSTATION)

THIS AGREEMENT AMENDMENT is made this 23rd day of August, 2018 by and between the County of Yolo ("COUNTY") and Luhdorf & Scalmanini Consulting Engineers, an individual ("CONTRACTOR"), who agree as follows:

AMENDED TERMS

1. CONTRACTOR shall perform the following ADDITIONAL personal services: Additional services as set forth in Exhibit B-3 with regard to the Wild Wings CSA water system.
2. CONTRACTOR shall perform these personal services between March 13, 2017 and December 31, 2018.
3. Subject to CONTRACTOR's satisfactory fulfillment of the terms and conditions of this Agreement, and upon CONTRACTOR's submission of an appropriate claim or invoice, COUNTY shall pay CONTRACTOR a total amount of \$36,500.

ADDITIONAL TERMS AND CONDITIONS

4. Increase total compensation by \$5,000 for a total amount of \$36,500.
5. Perform services as set forth in Exhibits B, B-1, B-2, and B-3. Except as set forth in this Fourth Amendment, the terms of the original contract shall remain unchanged.

Dear Ms. Gabor,

In follow up to your request, LSHDORFF and Scalmanini Consulting Engineers (LSCE) is pleased to provide you with a Scope of Work and a Cost Estimate for technical assistance for the on-going water system recommissioning including the Canvas Back and Pintail Well and Pump Stations, as described below:

1. Assist the water system operator with the operational issues with the jockey pump at the Pintail Well and Pump Station.
2. Continued assistance with the system operating procedures for remote filling of the Canvas Back tank, and operation the irrigation system using the Canvas Back booster system.
3. Assist with the control valving strategy for the roadway median landscape service connections to eliminate system hydraulic surging.

LSCE proposes to perform the work outlined above on a time and material basis for a budget amount NOT TO EXCEED the amount of Five Thousand Dollars (\$5,000). We have attached our "Schedule of Fees - Engineering and Field Services" for your reference.
