- 9. Mental Health Directors Report: Presented by Karen Larsen
  - Street Medicine RFP-issued RFO for street and mobile medicine and CommuniCare chosen as vendor. Starting contract negotiations. Included health systems money and whole person as well as CMSP money. Allows us to purchase mobile medical units. Will include physical health services, mental health services and possibly dental.
  - **FSP Transition**-Starting June 1<sup>st</sup> we will be beginning transition. Starting with TP client first. All clients have been notified. Laura's Law clients will also be transitioned. We are hoping to do some in person warm handoffs because we want the client to feel comfortable. Karen will provide a grid for who will be taking over FSP Clients for next meeting.

- **Governors May Revise**-2 billion to MHSA, BH world there is 4 billion dollars being invested in Children and Youth Behavioral health. Not all is county funding. There is several billion being invested in BH infrastructure. Quite a few investments in trying to keep people out of State Hospitals. One specifically calls out state hospitals will no longer be accepting LPS in State Hospitals. For our County that only applies to one that must be rehoused. A lot of concern for public safety.
