

Madison-Knights Landing Jetter

Agency: Madison-Knights Landing Community Services District

Amount Awarded: \$50,000

Project: This project funded the purchase of a jetter to be shared between Madison and Knights Landing. A jetter helps to maintain sewer systems by clearing obstructions in drain pipes.



Capay (SR-16) Flashing Speed Sign Replacement

Agency: Yolo County Department of Community Services

Amount Awarded: \$20,000

Project: This project funded the replacement of two speed signs that were previously installed in 2005 on SR-16.



Guinda Town Hall Improvements

Agency: Yolo County Administrator's Office

Amount Awarded: \$50,000

Project: This project funded grading, interior work (painting and patchwork), the completion of the septic system, and the completion of an overhang with handicap access.








Fire Department-Cache Creek OHV Response Units

Agency: Yolo County Administrator's Office

Amount Awarded: \$65,000

Project: This project funded the purchase of Off-Highway Vehicle response units to serve the Madison and Yolo fire districts.




No Man's Land Fire District

Agency: No Man's Land Fire District

Amount Awarded: \$16,000

Project: This project supplemented fire services to allow time through June 2021 for the completion of the Fire Sustainability study.



Knights Landing Levee Project

Agency: Yolo County Administrator's Office

Amount Awarded: \$589,000

Project: This amount helped to leverage \$15.1 million in State Cost share to provide levee improvements to Knights Landing.



Tuli Mem Operations & Maintenance

Agency: Yolo County Department of General Services

Amount Awarded: \$150,000

Project: This amount funded continued operations and maintenance of Tuli Mem Park located in Esparto.
