

# MINUTES Yolo County Advisory Redistricting Commission

# August 23, 2021

The Yolo County Advisory Redistricting Commission met on the 26th day of July, 2021, via teleconference at 6:00 p.m. pursuant to the Governor's Executive Order N-29-20 (March 17, 2020), available at the following link.

#### 6. Receive presentation on initial 2020 Census Data

Received presentation on initial 2020 Census Data as provided by Chris Chaffee. Mr. Chaffee noted that before the census numbers can be presented, the prisoner allocation must be done first. This information is expected to come out by September 23, 2021. He explained that from 2010 to 2020, there was 7.7% growth in Yolo County and based on the preliminary numbers, he summarized that District 1 will need to shrink and District 5 will need to grow. He also emphasized the importance of communities of interest input.

 Receive presentation on communities of interest and hold a public hearing to receive public testimony\*

Trini Campbell (Capay resident), Rachel Long (Zamora resident), Kate Laddish (Winters resident), Sheila Allen (Davis resident) and Dawn Borgnis (Capay resident) addressed the Commission on this item.

Received presentation on communities of interest as presented by Elizabeth Stitt and held a public hearing to receive public testimony. Ms. Stitt spoke about the public mapping tool, called District R, that will be very helpful to residents in creating a redistricting map. The Chair asked staff to agendize training on how to use this tool at a future meeting. One of the Commissioners raised the question of how to provide access to the community who may not have access to the internet and should still have the ability to provide their input. Alex Tengolics noted that written materials will be provided to the public at public locations throughout the counties, such as libraries and post offices.
