Dear Redistricting Commissioners,

We support redistricting Supervisor District 5 to include Winters and western Woodland ensure that we have a voice and representation in our rural community. Based on rural citizen input from local communities during this redistricting process, the following critically important issues unify us:

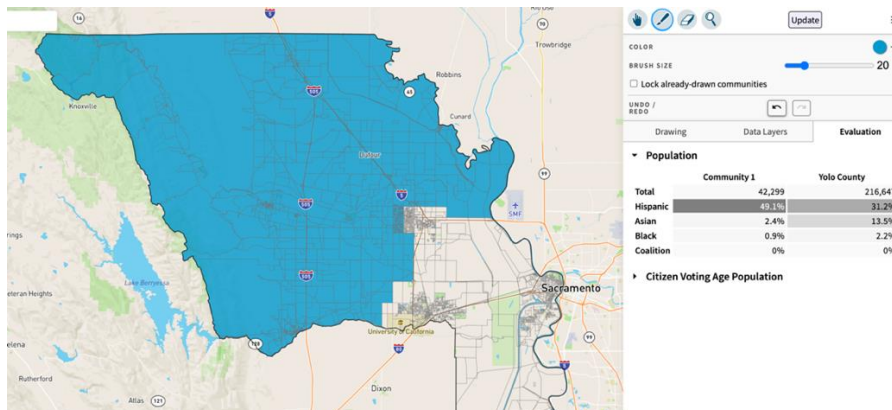
- Groundwater overdraft
- Fire risk
- Flooding
- Sheriff protection
- Broadband & access to community information, e.g., household mail & newspaper delivery
- Road maintenance
- Transportation for seniors

We align with the city of Winters in these needs. We also align with western Woodland from West St. west, to the north and south city limits. This is our community for the following reasons:

- Our kids go to school here in the Woodland School District: Zamora and Maxwell Elementary, Lee Jr High, and Woodland High. This is where we sent our son to school; he rode the bus.
- Agricultural businesses are here: We [REDACTED] do business with Holt Ag Solutions, Irrigation Supply, Amos Metz Rentals, Eaton Drilling, Gonzales and Les Schwab tires, Limagrain Seeds, Armstrong Insurance, Sterling May, NAPA and O'Reiley Autoparts, Wilkinson International, Grow West, Pacific International Rice Mill, Rain for Rent.
- Agricultural Services and Resources are here for us: Ag Commissioner, Farm Bureau, USDA Farm Services Agency, UC Cooperative Extension, Natural Resource Conservation Service.
- We mainly shop here for food and medicine: Raley's, Rite-Aid, Walgreens.

Below is a map showing our proposed new Supervisor 5 District in blue, that best represents our rural communities of: Dunnigan, Knights Landing, Yolo, and Zamora on the Hwy 5 corridor and Esparto, Guinda, Madison and Winters plus the Yocha Dehe Wintun Nation on the Hwy 505 Corridor. The current Supervisor District 5 map, including eastern Woodland, does not represent us; it is not inclusive of our community. Our kids do not go to school here, there are fewer ag businesses and ag resources, and it is distant from basic food and medicine needs.

Thank you for your attention to this very important process for us. We are looking for a voice and representation on critical issues affecting our rural community. Currently we rely on community networking and word of mouth to receive information on what is happening in Yolo County like where to get COVID shots. We no longer have newspaper delivery service from the Woodland Daily Democrat.
