4. Regular Agenda

(a.) SB 1383 Food Recovery Update - Marissa Juhler

The Edible Food Recovery Capacity Study and Funding Assessment has now been reviewed, finalized and ready for public release. (See attached)

The highlights of this report follow strategic short-term recommendations that allow for the increased capacity needed to service Tier 1 donors over the next 12-18 months.

The report identifies 9 recovery organizations that have current capacity to meet the needs of the Tier 1 generators. These 9 recovery organizations can be found on page 17 of the report.

The County and its four cities agree on the funding recommendations outlined on page 22-24 of the Study offering a variety of new items such as scales and refrigeration/freezer units to support these 9 organizations. This includes logistics funding to help shore up capacity pressures on the Yolo Food Bank (YFB) who is currently at capacity.

In total each of the 9 organizations would receive an estimated \$25K. In addition to assisting this network of organizations, the Study also recommends that we fund another \$387K directly to the YFB to assist with the purchase of a new truck, the cost of a new driver, fuel and insurance, a full-time program coordinator to expand current edible food collected from exiting donors and on-board the new Tier 1 donors required by SB1383.

Yolo County met with YFB staff on September 14th and YFB declined to accept this offer of funding. In preparation for our October 12th Board of Supervisors meeting, when this issue will be decided, Yolo County has started to develop a Plan B by reaching out to the other 9 organizations to see if they can fulfill some of the roles and accept the funding allocated should the YFB still decline to assist us in SB1383 compliance.

(b.) Member Updates

Yolo County - Marissa Juhler

Organics Waste Flow Agreements – Section 18994.2 (i) of SB 1383 requires each jurisdiction to provide Yolo County with evidence of organics capacity availability by October 1, 2022. To date, we have heard back from the City of Davis and finalizing City of Davis edits. In order to fulfill this requirement, we will also need agreements back from the City of West Sac, Winters and Woodland if choosing to secure capacity with Yolo County. To allow enough time for edits to go back and forth and these agreements to be approved by City Council and the Board of Supervisors, we recommend getting drafts back to Ramin no later than 12/31/21.

Composting Facility

The second reading and adoption is scheduled for November 17th.
