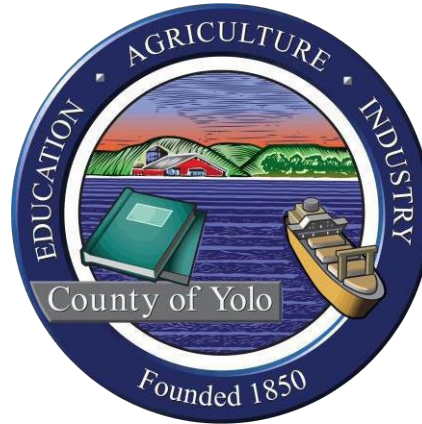

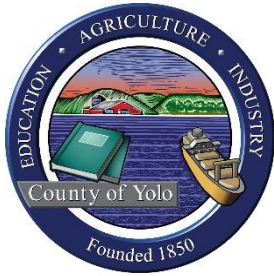

Subject: Remote Public Meetings

On September 22, October 20, and November 20, 2021 and January 4, 2022, I issued memoranda recommending remote meetings. The case rate in Yolo County has remained high since the January 4 memorandum and, while it peaked at 241 cases per 100,000 residents per day on January 8, it continues to represent high community transmission. In the context of high community transmission, I recommend meetings be held remotely whenever possible. I am re-issuing the earlier memorandum with updated COVID-19 case rate data.

In light of the ongoing public health emergency related to COVID-19 and the high level of community transmission of the virus that causes COVID-19, the Yolo County Public Health Officer recommends that public bodies continue to meet remotely to the extent possible. Board and Commissions can utilize the provisions of newly enacted AB 361 to maintain remote meetings under the Ralph M. Brown Act and similar laws.

Among other reasons, the grounds for the remote meeting recommendation include:

- The continued threat of COVID-19 to the community. As of February 2, 2022, the case rate is 129 cases per 10,000 residents per day. This case rate is considered “High” under the Centers for Disease Control and Prevention’s (CDC) framework for assessing community COVID-19 transmission; and
- The unique characteristics of public governmental meetings, including the increased mixing associated with bringing together people from across the community, the need to enable those who are immunocompromised or unvaccinated to be able to safely continue to fully participate in public governmental meetings, and the challenges of ensuring compliance with safety requirements and recommendations at such meetings.

Meetings that cannot feasibly be held virtually should be held outdoors when possible, or indoors only in small groups with face coverings, maximal physical distance between participants, use of a portable HEPA filter (unless comparable filtration is provided through facility HVAC systems), and shortened meeting times.

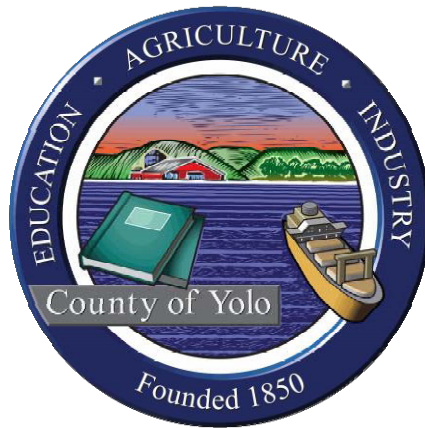

Re: Day Reporting Center (DRC) recidivism data and contract for DRC services

Background

Since 2013, Yolo County has contracted with the Sacramento County Office of Education (SCOE) to provide re-entry services for County probationers and State parolees. These services are provided through Day Reporting Centers (DRC) in Woodland and West Sacramento, and the Yolo County Jail, with the goal of reducing recidivism by successfully reintegrating offenders back into the community.

SCOE's current contract expires on June 30, 2022. With the current term ending, the Community Corrections Partnership (CCP) was recently asked to consider whether to conduct a competitive bid process for DRC services or to continue contracting with SCOE via a sole source justification as has been utilized in the past. As part of this discussion, the CCP received a presentation and data related to the DRC from SCOE. The CCP requested more current recidivism data before considering whether the contract with SCOE should be extended or a Request for Proposals (RFP) process be initiated.

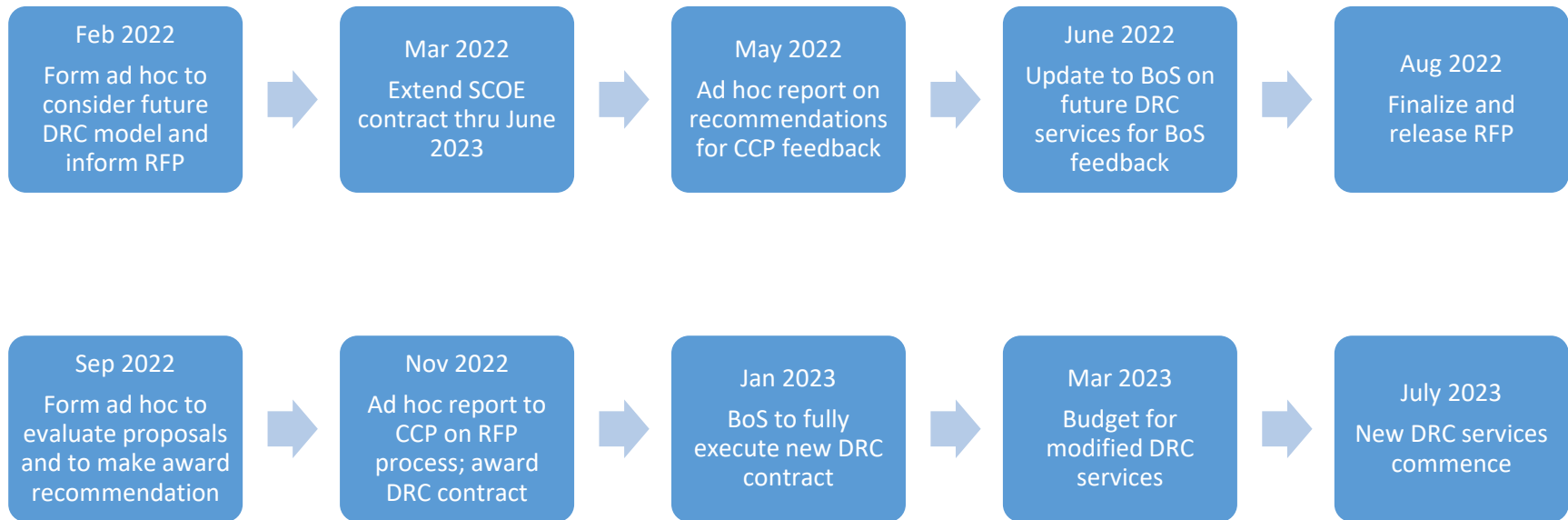
To assist in this data-collecting effort, the CCP formed a Recidivism Study Workgroup to evaluate and collect desired recidivism data. The workgroup consists of individuals from the Sheriff's Office, Probation Department, District Attorney's Office, County Administrator's Office, Information Technology Department and contracted criminal justice data expert Kevin O'Connell.

The Workgroup has met over the last few months to identify data sources, review relevant data and consider preferred data presentation points. O'Connell Research has worked with County departments to access the required data and conduct the necessary analysis to provide a current recidivism study.

Recommended Actions

- Receive presentation from Kevin O'Connell on current DRC recidivism data
- Given SCOE's employee contract timeline, which begins in March, and to ensure continuity of services, consider a one-year contract extension with SCOE for DRC services.
- Form an ad hoc subcommittee to evaluate the current DRC model, including in-custody programming upon completion of jail construction, and modifications to future services (i.e., evening and weekend hours, revised performance measures, etc.) to inform an RFP for future DRC services as outlined in the following next steps.

Yolo County Day Reporting (DRC) Center Overview

The program provides comprehensive services to people on probation, parole, or released from the Yolo County jail.

The program goal is to reduce recidivism by offering effective community integration and reduce re-offending behavior.

The Yolo County DRC follows a “Community Resource Center” model and works by addressing criminogenic needs through:

- DRC-run programming
- Referring to other programs partners

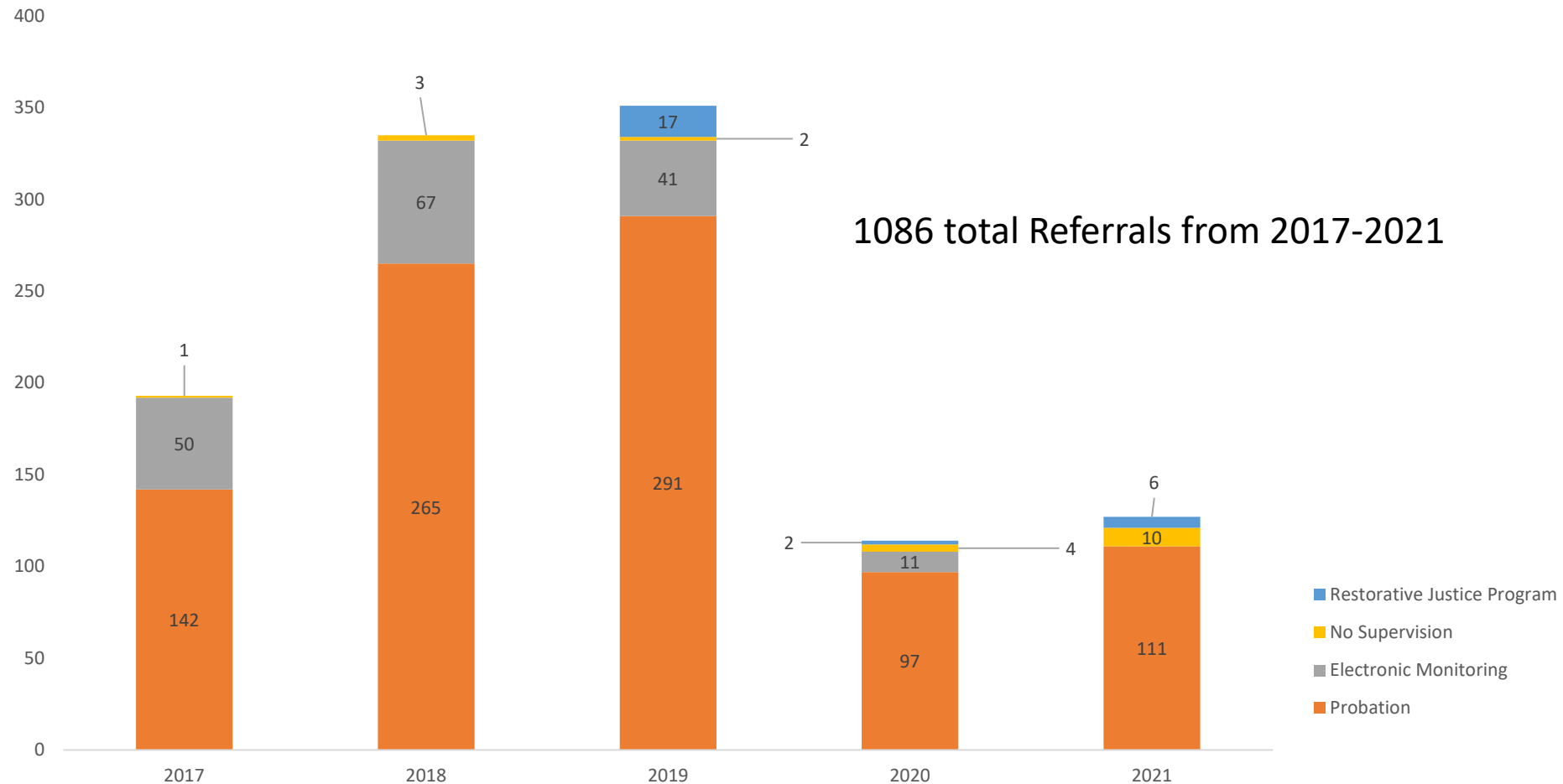

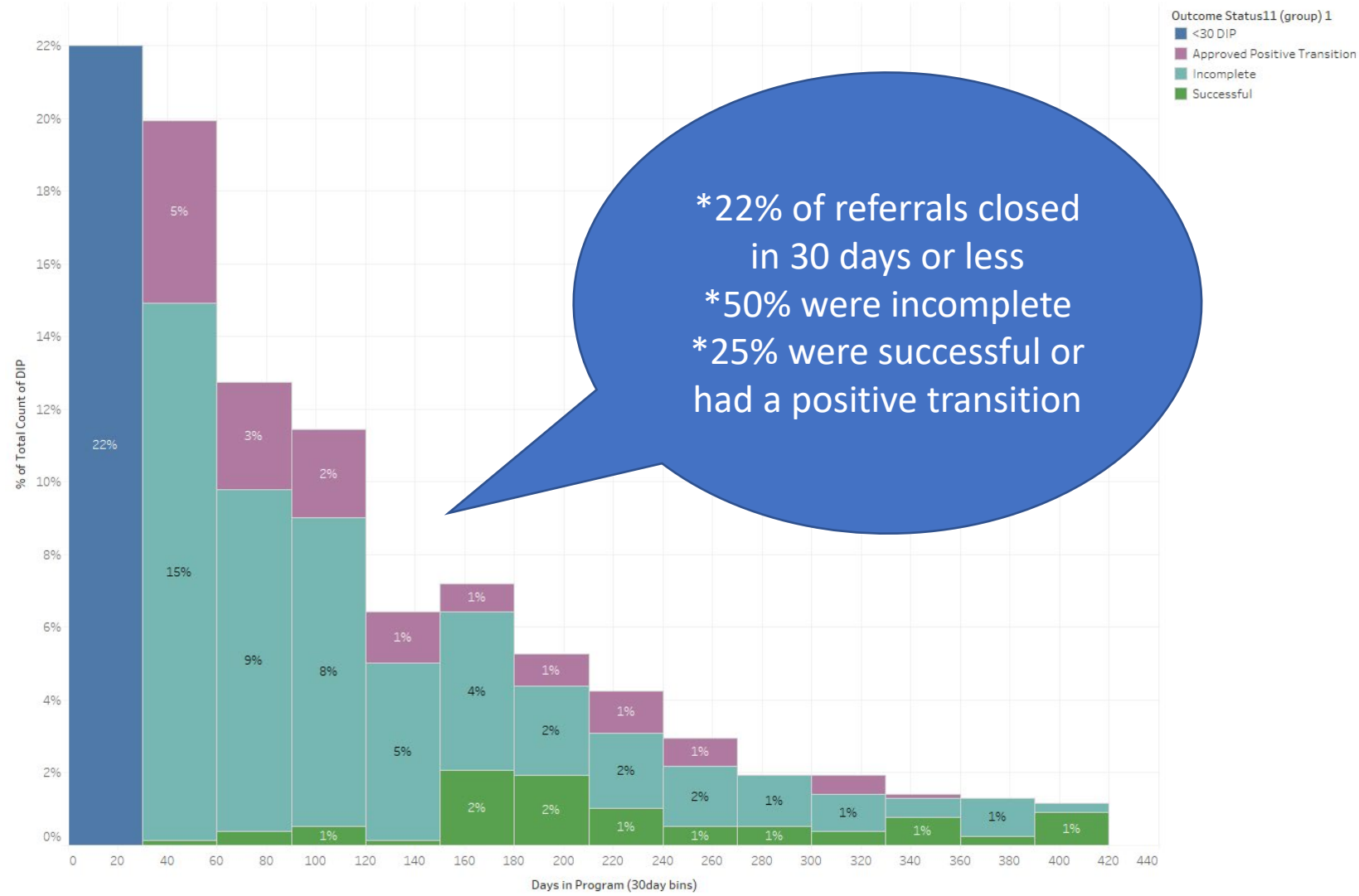

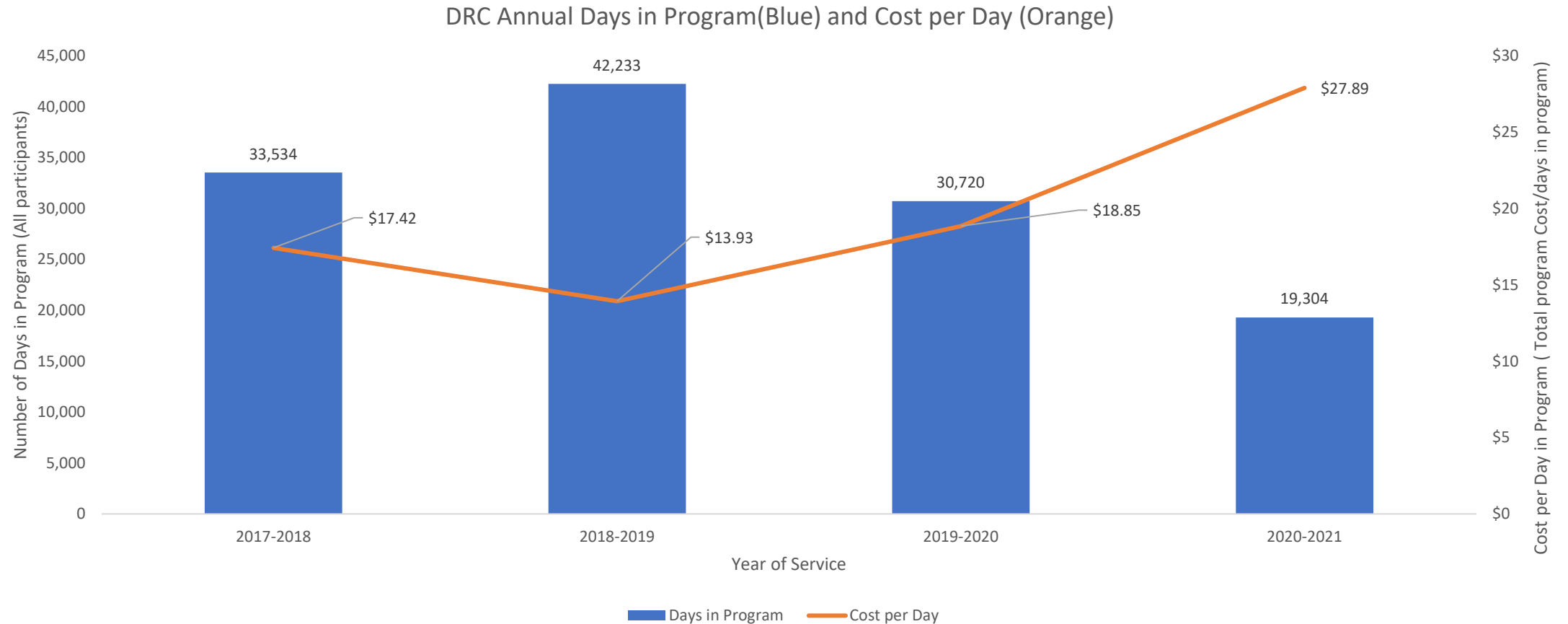
How long did people spend in the program (2017-2021)?

Considerations for using Recidivism

The Good:

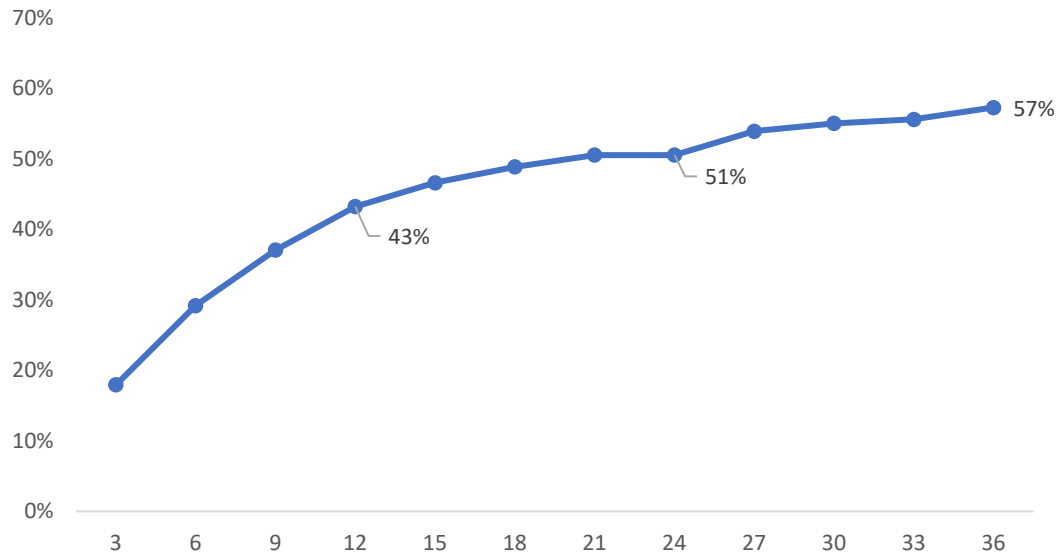
- Correctional interventions are supposed to reduce reoffending, so recidivism is a natural metric for success
- It can be measured at various points of justice contact to tell different stories about a program
- Can be grouped by “Cohorts” of participants for more comparability over time

The Bad:

- Doesn't allow for policy-relevant comparisons across groups by itself
- Lacks context by itself for what “good” levels represent
- Different groups recidivate at different rates, so there needs to be a comparison group

57% of referrals are rebooked into jail at least once within 3 years

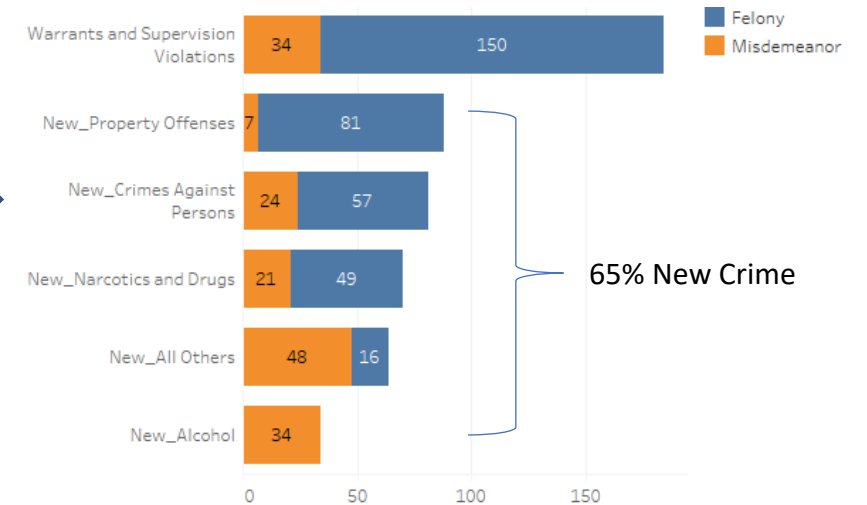
Jail Rebooking Rate (2017 DRC Referral Cohort), within a 3 year follow-up



2017 Program Cohort: 178 unique people



Jail Rebookings, by type



2017 Program Cohort: Averaged 4 returns to jail per recidivist

*Forming a comparison group for various client types would improve utility of jail rebooking data

*Multivariate analysis can help get more specific about how the program works and for whom

What did jail recurrence look like for subgroups over 3 years for the 2017 cohort?

Clients deemed "Successful" returned to jail 33% of the time over 3 years

Clients deemed "Incomplete" returned to jail 68% of the time

Women returned to jail less often than men

More days in the program were correlated with lower jail rebookings

People with an Serious Mental Health Need and/or homelessness returned more often

Develop a comparison group for different referring agencies and sub-populations



Create a profile of clients served by DRC programming dosage to inform future program development



Develop recommendations around program improvement opportunities
