- a. SB 1383 Food Rescue – Marissa Juhler
  - The contract we signed last month between the Esparto Valley Market and the Countryside Church is going well. In the first four weeks we collected 66lbs. This shows the process is working.
  - Funding Program Recommendations – information will be provided at the next Waste Advisory Committee Meeting.

- b. Member Updates

- Yolo County** – Marissa Juhler

- No new updates on engineering side or construction
    - SB212 Solid Waste: Pharmaceutical and Sharps Waste Stewardship – Starting in September of this year we are going to start being able to potentially have our pharmaceutical kiosks cost covered as part of the SB212 program. Along with possible cost covered for the pharmaceutical kiosks, SB212 will give us the ability to add sharps kiosks to locations or seek funding for reducing current cost through our Household Hazardous Waste facility. Which is our existing collection location for five jurisdictions.
    - Textiles SB1383 – The landfill will be accepting clothes through our Big Blue Barn. But because we are still the barn and we cannot sell clothing out of our location. We have partnered with “I choose Life, ICL an Africa based company. They will be providing a regular Collection of all the textiles.

- City of Winters met with Lorenzo Market, which is our tier one generator. We were able to finalize the details of our partnership agreement to distribute edible food received from Lorenzo’s Market at Rise Inc on Baker street here in Winters.

- City of Woodland just meet with our two food recovery organizations. They are doing a great job with expanding and reaching out to the tier one generators here in Woodland.

- Cal Recycle SB1383 Training – Most of us went to the training offered by Cal Recycle for SB1383.
