1. CALL TO ORDER

Chair Ullrey called the meeting to order at 6:30 PM.

6. REGULAR AGENDA

6.1 ARP Funding Update

Eric Will, ARP Project Manager with the County Administrator's Office, gave an update on the process, progress and recommendations for allocating ARP funds for parks. The team

assembled for allocating the funds met a number of times over the past three months and those recommendations were reviewed by the Board liaison team two times as well. A robust discussion ensued which included these committee member comments:

Campbell: Esparto is expanding and consideration should be given to the future needs in that community.

Shukis: Some parks are in disrepair and those should be given consideration. Further, marketing of parks that have needs for improvement would be premature.

Cruz: Raised a concern that these one-time funds will run out and efforts for Programs will not be sustained.

Ullrey: was very supportive of completing the Valley Vista trail system as it addresses both goals of the ARP.

6.2 Prop 68 Grant Applications

Mike Martinez, GSD Project Division Manager, gave an overview of the Prop 68 Per Capita Grant applications. Those included more solar and a new car port for an additional host at the campground, playground replacement and new shade structures at Esparto Community Park, a better pool cover to reduce chemical use and staff labor at Tuli Mem Pool, new shade structures in the picnic areas of Tuli Mem Park, and expanding the ever-popular Grasslands Dog Park parking lot. We continue to work with state parks about their award schedule.

7. DISCUSSION ITEMS/PARKS DIVISION STAFF UPDATES

Cache Creek Campground: The campground will open on April 1, 2022.

Tuli Mem Aquatic Park: Shade structure installation update. Opening set for May 28.

8. COMMITTEE MEMBER AND DIRECTOR REPORTS

Yarris shared that the Board of Supervisors unanimously approved the first reading of the OHV Ban in Cache Creek. A second reading is coming to the Board for final approval.

Fulks shared that UC Davis is completely overhauling the Putah Creek Arboretum in effort to return the area into riparian and wetland habitat.

Campbell commented on the new shade structures at Tuli Mem Aquatic park and all the positive community feedback about them. (parks art mention?)

Ullrey mentioned that CalFIRE would be conducting a prescribed burn workshop for state decision makers at the Cache Creek Nature Preserve's Tending and Gathering Garden. The program is in conjunction with the UCDavis class called "Keepers of the Flame," which is a cultural fire workshop. It is by invitation only, on March 8. She also mentioned that the Yolo Habitat Conservancy has a California Department of Fish and Wildlife grant to complete a Reserve Unit Management Plan (RUMP) for the lower Cache Creek. She suggested that it might be a good topic to present to the committee.
