Joint Apprenticeship Training Committee (JATC) Applicability

Issue

The Foundation for Fair Contracting (FFC) expressed concerned about the Department of Community Services recently awarded a contract for the 2022 Pavement Preservation project. The FFC expressed concern regarding award of the agreement to a contractor who was not a JATC member.

The Department of Community Services classified the 2022 Pavement Preservation Project as a road maintenance project instead of a construction project and thus did not apply the JATC requirement. The FFC's inquiry raised questions about the scope of the County's JATC requirement.

Discussion

The current County Policy on Procurement applies the JATC requirements to public works construction projects valued of \$1,000,000 or more. Specifically, it states in pertinent part: "Public works solicitations for **construction projects** estimated to cost more than \$1,000,00 shall contain a joint apprenticeship committee requirement. Bidders are required to demonstrate that they are an active member of a joint apprenticeship training committee or joint apprenticeship committee with their bid submission." Emergency projects are exempt from the JATC requirement.

Staff have applied the JATC policy to construction of new facilities or reconstruction/renovations of existing facilities, but not maintenance projects, as opposed to all public works projects. Most recently, the JATC requirement was applied to the Leinberger Jail project and the ITS Relocation project. Staff have not applied the JATC to maintenance. In making this determination, staff have typically applied the State law definition of what constitutes "maintenance," which is defined as:

- routine, recurring, and usual work for the preservation or protection of any publicly owned or operated facility
- 2. minor repainting
- 3. resurfacing of streets and highways at less than one inch
- 4. landscape maintenance

The Department of Community Service's decision not to apply the JATC requirement to the 2022 payment preservation project is consistent with past practice. The Department, however, did require compliance with the apprenticeship requirements under the Prevailing Wage Laws that apply to public works projects over \$30,000. (per Labor Code § 1777.5.) We are working with staff to apply the State law definition of "maintenance" consistently in deciding whether a project constitutes a "construction project" for purposes of the JATC requirement.
