4. Regular Agenda

a. SB 1383 Food Rescue Update – Marissa Juhler

The UC Davis Food Pantry and Mercy Coalition have been added to the list of local food pantries
who have contracts in motion to be signed. The Yolo Food Bank has also re-engaged in
conversation with Yolo County about partnering on SB1383 efforts and seeking funding for
participation in helping the five jurisdictions meet their goals.

b. Member Update

Yolo County – Ramin Yazdani

- The new landfill module is close to being completed. This is the area we are going to accept waste staring in 2023.
- The compost facility is up and running and is currently at full compacity. We are still waiting for PGE to connect the facility to the grid. Currently the facility is running on generator power.
- The WMU G pond reconstruction is in progress and is expected be finish by October/November 2022.
- Solar projects for all operations at the landfill will be going to the board on September 23, 2022 or approval. Project will be constructed in 2023/2024.

Yolo County - Marissa Juhler

- During the August tire amnesty event, Yolo County logged 151 participants and collected 1,534 tires.
- Yolo County will be participating in the Yolo car show on August 27th. Our booth will be focusing on used oil and filter recycling.
- September starts the beginning of the SB 1383 required contamination minimization program. We will be walking the streets of each of our rural residential communities "flipping the lids" of waste, recycling, and organics carts, looking for items that are incorrectly placed. We will then tag the bin educating customers on proper disposal, recycling, and organics compliance.

City of Davis – Richard Tsai

- We are reminding residents of our August move out; reuse and recycle when possible.
- The SB1383 carts are in; the city of Davis will replace the new carts as needed.
- Davis bulky waste landfill vouchers are valid until the end of September.

West Sacramento - Traci Goularte

 West Sacramento is working with Yolo County on the 2023 recycling calendar. The calendars should be coming out soon.

Woodland - Rosie Ledesma

- SB1383 will rollout phase three of organics which is the residential sector last phase.
- Waste Management will be sending out updated brochures for commercial and residential services. The residential brochure will include a coupon voucher to use for a free food scrap pale.

U.C. Davis – Josh Morejohn

 UC Davis continues to work on the ammonia extraction unit on our renewable energy and aerobic digestor. With some delays it should be coming online in the next few weeks.
