#### RESOLUTION OF THE YOLO COUNTY BOARD OF SUPERVISORS TO AMEND THE YOLO COUNTY GENERAL PLAN ADDING THE BARN AT UTTER RANCH AND UPDATING ADDRESSES TO THE LIST OF COUNTY-RECOGNIZED HISTORICAL RESOURCES IN UNINCORPORATED YOLO COUNTY

WHEREAS, the policy of the County of Yolo ("County") is to promote the public health, safety, and general welfare by providing for the identification, protection, enhancement, perpetuation and use of improvements, building, structures, signs, objects, features, sites, places and areas within the County that reflects elements of its cultural, agricultural, social, economic, political, aesthetic, military, maritime, engineering, archeological, religious, ethnic, natural, architectural and other heritage; and

WHEREAS, Ordinance No. 1445 authorizes the Planning Commission to act as the Historic Preservation Commission, with the help and cooperation of the Historical Advisory Committee, to recommend to the Board of Supervisors the designation of Historic Landmarks and Historic Districts; and

WHEREAS, the owners of the proposed location have provided documentation of the site's historical value; and

WHEREAS, the Historical Preservation Commission adopted Resolution 2022-01-HPC recommending that the Board of Supervisors add the Barn at Utter Ranch to the list of County-Recognized Historic Resources in unicorporated Yolo County; and

**WHEREAS,** Ordinance No. 1445 authorizes the Community Services Director to process nonsubstantive corrections to the General Plan for approval by the Board of Supervisors;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors approves the updated addressing provided on Table CO-6 of the Conservation and Open Space Element and hereby designates the following structure as a Yolo County Historical Landmark:


