Note: (B) A funding request was previously submitted to the Doyuti T'uhkama with Yocha Dehe Wintun Nation. \$1 million was pledged to create an endowment for maintenance costs if state grant funds were obtained. The County needs to confer with Yocha Dehe on the project and the previous pledge.

Note: (C) FY2022-23 funds set aside in amount of \$225,000 for contribution to Capay Valley Health Center. \$225,000 expected to be available in FY2023-24.
