#### **New Park Sign Concepts**

Problem: There is no common County Park Signage. Two parks have signs that need to be replaced, Putah Creek Fishing Access Site 3 (District 2) and Dunnigan Community Park (District 5). Proposed sign concepts are below. Approximate cost is \$3,500 per sign that will last 10+ years.

Concepts: Signs will have both the County logo and the Parks branding logo. Putah Creek must have an acknowledgement to the State Wildlife Conservation Board. Some local agencies will include the name of the District Supervisor on the sign. Two color options are presented for the Supervisor name. This committee is asked to consider sign concepts and provide feedback.
