Agenda Item No. 5.03 Executive Director Comments

Received comments from the Executive Director, Lisa Baker, who addressed the Board of Commissioners and provided an update on the following issues:

• Yolo County Housing received a low loss achievement award for the years 2004, 2005,

Yolo County Housing October 2, 2008 and 2006 honoring them for their positive performance in achieving low loss ratios for general liability over the past three years.

- Yolo County Housing received a thank you letter for their participation in the First 5 Yolo Children and Families Commission Focus groups.
- The San Francisco Office of the Department of Housing and Urban Development created an Office of Public Housing Newsletter, and Yolo County Housing is profiled in the newsletter in the "What A Good Idea" section, referring to what they have been doing to reduce their Carbon footprint and improve operations costs through greening their business practices.
- Regarding MHSA Housing, they closed on the Trinity property, held a neighborhood meeting with the neighbors, and are moving forward with the plans and designs; regarding the Meadowlark property, they are still in escrow waiting to receive some reports, and hope to close soon.
- On the TANA project, they have been working with the City regarding the Block Grant draft bid package, it will to go to the attorney at U.C. Davis, and they hope it goes out for bid in a couple of weeks.
- The agricultural season continues and they have received requests for extensions from all three migrant centers, normally they pay for those operation extensions out of their Care Program; they have about 75K for all three programs, which could carry them through extensions, but they have a problem with the adopted budgets; they don't know if the budgets will be modified by the state's final approved budget, they are significantly lower than the funding they have been receiving, but they think there is sufficient reserved funds to potentially not have too much impact on the Davis and Dixon Migrant Center; but the Madison Migrant Center, due primarily to the sewer, water and flood insurance charges, is in a world of hurt financially in terms of what they could do. They are looking at options for all three budgets. They believe operations will be affected somehow, but they don't know at this point.
- Commissioners asked the Housing Authority Director to place the Madison water and sewer fees on the next agenda.
- Regarding the double stabbing, they were on Fox 40 News and in the Sacramento Bee; residents were interviewed and told reporters that the majority of issues in that community are caused by individuals that come in to their community and use the park.
- Yolo County Housing participated in the Yolo County Youth Substance Abuse forum, and are working with the City of Winters on ways to address those issues in Winters.

- Commissioner Yamada reported the Yolo County Commission on Aging and Adult Services is doing a 4-year area plan to look at a needs assessment for seniors; they are looking for additional sites to serve as distribution points for the ongoing survey; the survey is opening up on Monday, October 6, 2008. There are four target groups for ages 60 and older.
- Commissioner Yamada reported her office received a call from the Franchise Tax Board. They are looking for additional sites to provide trainings on Earned Income Tax Credit (EITC), and they also need volunteers.

Supervisor Rexroad recused himself from Agenda Item No. 3.03 and Closed Session due to a conflict of interest and left the meeting at 3:22 p.m.
