**Membership terms:** Board appointees terms are dependent on the Supervisor's term of office.  
4-year terms commencing Jan 1

**Frequency and time of meetings:** Second Tuesday of every month from 4:30-6:00 p.m., alternating among Woodland, Davis and West Sacramento. For low-income members, travel costs are eligible for reimbursement.
