**Makeup of membership:** 15 members appointed by the Board of Supervisors

One permanent member, who shall be a member of the Board of Supervisors

Fifteen rotating members appointed as follows:

- (1) At least fifty percent of the members shall be consumers or the parents, spouse, sibling, or adult children of consumers, who are receiving or have received mental health services.
  - (2) At least twenty percent of the total membership shall be consumers and at least twenty percent of the total membership shall be families of consumers.
  - (3) At least one member of the board shall be a veteran or veteran advocate, as defined in Welfare and Institutions Code Section 5604(i). To ensure compliance with this subdivision, the Board of Supervisors shall notify the Yolo County Veterans Services Office about vacancies on the board as they occur.
