#### **Consent Agenda:**

#### Mental Health Directors Report-Karleen Jakowski

- Medi-Cal Mobile Crisis Benefit-working on developing plan, required to submit by October 31<sup>st</sup>. Developed internal workgroup to identify what our gold standard what look like. We will have an idea on what we need by December 31<sup>st</sup>. 5 budgeted PSW positions with two already filled. Also evaluating for after-hours coverage what 2-person team will look like. Exploring what our options are and how to meet the need. Likely to really shift towards regionalized services. Will always have some number of coresponders embedded with law enforcement agencies but what we want is to have mobile crisis teams not attached to a law enforcement agency. Working on for billing portion and how to account for downtime. We have a contract with RI International, they created the mobile crisis model
- MHSA Reform Proposal- Nicki King asks, didn't they recently change something on it? Currently can only fund co-occurring substance use services. No funding for Substance Use Disorder (SUD) services only but it does open the criteria. No mandate for stand alone SUD but it will take away MHSA funding to support SUD and has potential to dilute the funding for housing and Mental health services. Nothing in the reform that mandates funding "yet". A lot is focused on housing and the crisis we are seeing with the number unhoused with Mental Health/SUD needs. Just opens the door to leverage the funding for SUD services. They also want to change the name to Behavioral Health Services Act instead of Mental Health Services Act.

### **Regular Agenda**

**Board of Supervisors Report**: No supervisor representation at today's meeting. Jonathan will reach out to BOS chair to discuss representation at future meetings.

**Criminal Justice Update**: Chris Bulkeley-Mental Health Graduation coming up July 10<sup>th</sup> at 2 pm in Department 5. Individual graduating has a lot of cases with his fingerprints coming through from years ago from unsolved theft cases, so his graduation and getting through this was a major accomplishment. Criminal Justice side we have some grants that are being worked on.

# Public Comment on CJ Report:

• Christy Correa-Can we have a Criminal Justice Update on how many on waiting list for FSP is there a backlog for people to get into MHC? Currently 10 for MHC, for FSP the forensic team is working on allocating. There have been some staffing challenges. JAG grant, interview for BH Case Managers. Starting in September we will have 20 new FSP slots but waiting on approval for MHSA. FSP currently at capacity with current staff. Some challenges with some who are MIA or declining services and difficult to locate. For folks in custody, it can be a barrier to getting released. MHC has 25 we will take 30, Addiction intervention Court has 28 and we will take 30. Number of issues beyond HHSA staff with connecting to jail with technology.
