# 5.1 Esparto Community Park, Play Structure Update – Ryan Pistochini

Pistochini reviewed Option 1 selected by community vote held on July 12<sup>th</sup> with SUP Barajas office, and the selected pour in place rubberized surfacing to replace the existing wood chips. PRWAC discussed the pros and cons of rubberized surfacing, specifically bringing up thermal retention.

5.2 Movie in the Park Night, Esparto Community Park – Ryan Pistochini

Pistochini updated PRWAC Movie in the Park Night held August 5th, that was co-hosted with the Esparto Chamber of Commerce. Suggestion was made to mail out a flyer with event details if there were to be another event.

5.3 Tuli Mem Pool Update – Ryan Pistochini

Pistochini shared details with the committee about the closure and reopening of the rec pool at Tuli Mem Aquatics Center from the line actuator equipment failure.

5.4 CA State Library Parks Pass Grant: Story Walk Siting – Ryan Pistochini.

Pistochini shared the Parks Division's partnership with the Yolo County Library through the California State Library Parks Pass grant program and future siting selection for the Story Walk to be installed at Capay Open Space.

5.5 Putah Creek Fishing Access Tour with Sup. Frerichs – Ryan Pistochini

On July 6th, Parks hosted Supervisor Frerichs and his staff on a site tour at Putah Creek Fishing Access and shared project aspects of the WCB grant pre-application that was recently submitted. PRWAC expressed support of the application and discussed potential additional uses.



Grasslands Dog Park is only useable for 3-4 months out of the year because foxtails have rendered it too dangerous to enter. The county's lack of an effective invasive weed abatement program for Grasslands Regional Park is astonishing. Stating that "foxtails are everywhere" is an unacceptable response to this ongoing hazard and is not a substitute for the lack of an effective abatement program.

Mowing foxtails is not an appropriate management practice as it only serves to spread the seeds and after mowing the new seed heads will erupt lower to the ground making all future cutting impossible. As of now, a controlled burn would be the only way to reduce the enormous load of foxtails and seeds present. It would serve to eradicate the bulk of the foxtails and provide nourishment to the soil. A burn would then be followed up with a shallow disking and planting a mix of ground cover. Disking without burning first would just plant more foxtails.

In the spring, when the new grass sprouts, the dog park field should be rotated with the sheep pasture, so invasive weeds are grazed before seeds erupt. This would save the county time and effort by letting the sheep do the work of removing the weeds.

The county not only lacks an abatement program but also the staff and equipment needed to execute it. Proper equipment should be in place to allow for catchment of mowing debris, for watering new plantings and controlling burns plus temporary fencing and gates that can be moved/installed with minimal effort.

There should be an Environmental Management internship/volunteer program for assisting staff in these efforts. The proximity to UC Davis/Cooperative Extension provides immediate consultation and an endless supply of students looking for research projects, units and experience. There is also the California Conservation Corps, Boy/Girl Scout Troops and mandatory community service youth begging for projects to tackle. And locally there is the Yolo PBA and Grizzly Corps to assist with controlled burns and revegetation projects.

The managers of the levees along the Sacramento River and causeway are able to conduct controlled burns/replanting on the levees each year, the county should reach out to them for help developing an abatement program and assisting with the burns.

An effective abatement plan would be on-going year-round management with a mixture of mowing, weed whacking, sheep rotation, safe-herbicide use, controlled burns, disking and replanting. Because of the current lack of effective management, intense measures will be required for the next few years. When significant progress has been made these efforts can be dialed down to maintenance level.

Grasslands is a very popular destination for dogs and people to recreate in the county. The parking lot is full most of the time and everyone enjoys visiting the park. The goal should be to have a safe, usable place for families and dogs to enjoy year-round.

Thank you very much for agreeing to take comments to the Committee for those of us unable to attend tonight's meeting.

#### My comment is regarding the fencing on the North perimeter.

The squares of the fencing along that perimeter, which is adjacent to the sheep grazing area, are so large my medium sized dog hopped right through and took off towards the sheep! Luckily I called her back successfully and neither she not any sheep were harmed (they were quite a ways away) but it was a very tense 15 seconds! Had I not been able to recall my dog I am sure she would have chased the sheep, endangering them and her. We have not been back to Grasslands since.

I strongly urge the committee to audit the fencing and ensure the metal mesh is ALL the same small(est), dog proof size.

The larger metal mesh size, adjacent to the sheep grazing area is a hazard to dogs and sheep. I can't believe my dog is the only one smart/athletic enough to size up the opportunity and slip through those larger openings.
