- 2. Welcome New CBO Partner: De Colores Resource Center!**
 - Esmerelda Garza (CEO) and Esmerelda Mandujano (CFO) were introduced.

- It was shared that the De Colores Resource Center was founded with the goal to improve health outcomes in the farming community.

3. CAAP Youth Calendar Art Contest (*Attachment A*)

- Various components of the CAAP Youth Calendar Art Contest were discussed. Recommendations on the art prompts, judge selection, art submission mediums, and groups to conduct outreach to were made.

4. November Workshop Series Plan

- The Overall Calendar for the CAAP Community Workshops was discussed. It was shared that the Madison Migrant Center was intended to be included on the workshop schedule for outreach, but after conversations with our CBO Partners and internal staff, it is not a possibility at this time.
 - Staff shared that current workshop locations include Davis, Woodland, Guinda, West Sacramento, Dunnigan, Clarksburg, and Winters.
 - The mediums for data collection for workshop participation were discussed. It was asked if the workshops are bi/multilingual or just English. A response was made that in past workshops there was an optional pre-registration form where individuals could select whether they needed a translator. A translator was present at past workshops but was not utilized. Unsure if there was an issue with outreach, and if so, how to bridge the gap. It was asked if childcare will be provided at the workshops. A participant responded that childcare will be provided.
- A participant inquired if moving the workshops for the beginning of November (Guinda/Capay and Clarksburg) to December would be more beneficial.
 - Participants were directed to a sign-up sheet to volunteer as support for CAAP Community Workshops.
- The CAAP Community Workshops flyers were shared with the E&E TAC for feedback.
 - A question was asked about the expected turnout.
 1. A participant responded that 10-15 people are expected.
