- 7. HPAC Update- HPAC Chair Zeck
 - New HPAC Chair: Thank you to Jeneba Lahai for here great work as previous HPAC Chair.
 - New HPAC Executive Director: Addressed in monthly meeting New executive director "Wendi Counta" has been in place for three months and is catching up with the tasks involved with grants and funding sources.
 - Next focus: HPAC would like Employ an analyst to support Wendi in her efforts. HPAC has been using a contactor to do a lot of the interim training and development for the executive director onboarding, as well as satisfying all other needs for funding sources.
- 8. Staff Presentation- Ian Evans
 - General Staff updates
 - County Plan HHAP 4 Last Month East Beamer Way Permanent Supportive Housing with help of the Hope Cooperative – All sixty homes are now full.
 - ii. Groundbreaking for Walter's House on January 13th MLK Weekend
 - iii. Paul's Place County Partnership with ARP/HHAP funds Emergency Shelter Bed's, Transitional Housing and 18 PSH units.
 - Chris Richardson: Downtown Streets Team (DST) Presentation
 - i. Chris Richardson and Heather Mundy introduce the programs founding principle: "Homelessness is an experience not an identity": Working to Change the narrative of homeless identity.
 - ii. DST is focusing on the method of a Psychosocial Vocational Rehabilitation through Structural Daily Activity (community beautification) in exchange for stipend program.
 - iii. 2018 League of CA Cities (Institute of local government)–Homelessness Task Force: Identifies DST as 1 of 5 Evidence-based Best Practices and the only program to grow out of a single community.
 - iv. New Programming: Streets Team Enterprises Supportive Transitional Employment – Largest Employer of all time for DST.
 - Davis Plan: Standing Team 15 Team members, 4 clients per team member (60 total); Employ 1 Project Manager and 1 Case Manager/Implementation Specialist hybrid position.

- vi. DST recently rolled out a Data Impact System (proprietary) which launched to track efforts and success
 - Josh Chapman: As a small business owner in DT Davis, Josh was curious what the onboarding process is for DST team member selection and recruitment.
 - Chris Richardson: Connect with Davis service providers, offer an Orientation Meetings, and a Provider Meeting to help identify those who are ready to be enrolled into the program.
 - Dana Bailey; Working with DST by connecting clients to Davis Community Meals and Housing and Respite Centers.
 - Quirina Orozco: In Sacramento, the Homeless Coordinator helped in the process to identify those who are ready for onboarding.
 - Martha Teeter: Was involved in Davis Pathways to Employment in 2016 and wonders what DST is doing to integrate similar programs and incorporate input from the Davis Downtown Business Association.
 - Dana Bailey: Answers with Bill Pride says Davis Pathways is no longer operating but is working on transitioning clients from similar project to DST.
 - Chris Richardson: Working with Brett from Downtown Davis Business Association, both DST and the association have similar goals in mind.
 - Rich Lansburgh: Describes Woodland's plan to pursue the DST program as the "wait and see" approach referring to the success of the program in neighboring cities, budget was not previously approved.
 - Doug Zeck: How is this being funded by each jurisdiction, and how the sustainability of that funding moving forward.
 - Drago Fierro: Reiterates Rich Lansburgh's position on the DST program, may consider involvement in the future.
 - Dana Bailey: Makes a point that DST does a very good job of finding ways to make their program self-sustainable as far as funding goes.
 - Ian Evans: Makes the point that the state just released another round of Encampment Funding, could be used for programs such as DST.
