• Executive Director Wendi Counta has recently hired a new analyst, which brings their team to the level where they have budgeted and anticipated for. Homeless Housing Assistance and Prevention HHAP 4 application has been sent out and they're waiting to hear back on that process. A point in time (PIT) count will be happening at the end of this month, it will be a sheltered count this year and be done on January 24th.

General Staff updates

- Beginning of this week, 30 individuals enrolled in Project Room key in West Sacramento, 2 additional COVID positive placements in Woodland, 57 additional Home key participants in West Sacramento.
- Project Room key has a projected March end date to the project, and they
 are actively working with the City of West Sacramento to ensure a smooth
 transition for the remaining Room key clients that are in the current hotel in
 West Sacramento and for a transition to the new hotel the city is
 purchasing.
- In the city of Woodland, 4th and Hope made additional beds in the dining room to prepare for the increase in people seeking shelter in the storm.

- The program is intended to serve individuals who are living homeless while still prioritizing the use of HHAP funds to assist people experiencing literal homeless, move into safe, stable, and permanent housing.
- Allocation has not been determined by the California Interagency Council on Homelessness (Cal ICH), but Yolo County's HHAP 3 allocation was just over \$914 thousand (\$914,977.42). It is anticipated to be a similar allocation. Of that, 10% of the total allocation must be used to provide services to the homeless youth population and no more than 7% of the total allocation can go towards administration fees.
- Eligible uses are rapid rehousing, operating subsidies, street outreach, services coordination, systems support, delivery of permanent housing and innovation housing solutions, prevention and shelter diversion, and interim sheltering.

iii. Survey Results

- 33% of responders identified as government officials/employees
- 56% services providers
- 29% have attended almost every meeting
- 16% have attended 75% of meetings
- On a scale of 1-5 with a score of 1 not being impactful and a score of 5 being very impactful
- 3.3 on being impactful on strategies that address homelessness in Yolo County
- 3.4 on the policies and decision-making in addressing homelessness in Yolo County
- 3.6 on funding decisions to address homelessness in Yolo County
