- 4) PUBLIC REQUESTS
  - a) None
- 5) INFORMATIONAL ITEM
  - a) Levee Repair – Dave Wheeldon, Department of Water Resources
    - i) 4 repairs associated with 2017 high water in Clarksburg. Will be repaired under the SDDER program (State-led storm damage repairs)
      - a) Site 52 and 53 in Elk Slough were completed in 2020
        - i) Already seeing seed emergence from the hydroseeding
      - b) Site 61 (River Rd and Netherlands Ave) and 63 (River Rd and Pumphouse Rd) will be done by December 2021
    - ii) Site 61 has 1000' feet of erosion. Need to restore levee geometry and protect bank
      - a) Materials used include soil-filled rockfill, geotextile fabric, in-stream woody material, willow pole cuttings and launch rock
    - iii) Beck inquired about seepage on Site 61. Mr. Wheeldon said that this project was not designed to correct that specific problem. He added that the State is working on how to address seepage issues

  - a) There was discussion about the road construction and traffic delays. Beck asked for the traffic control schedule. Marianne Estes said the work was ongoing and fluid and that there was no way to know when traffic would be delayed and for how long. She also said that she would provide the phone number for the project lead that way the community could ask questions directly
