- 2) APPROVAL OF AGENDA

- 3) APPROVAL OF MINUTES

- 4) PUBLIC REQUESTS
  - a) None
- 5) INFORMATIONAL ITEM
  - a) Introduction of Yolo County Public Information Officer – John Fout
    - i) His role is to handle communications within the County (press releases, etc)
    - ii) His email is: John.Fout@yolocounty.org
  - b) Signage on River Road – Nicholas Burton, Yolo County Public Works
    - i) Check with County regarding No Trespassing signs to ensure they are clear of the public right of way
    - ii) Reamer enquired about the signs currently on the levee that have faded
      - a) Burton noted that those signs were installed by the Reclamation District not the County
        - i) Reamer said she would approach the RD regarding new signs
  - c) River Road Improvement Project – Nicholas Burton
    - i) Project is complete
    - ii) There is consideration about installing “speed striping”. There are no guidelines for the striping, but it could be a way to slow drivers moving at excessive speeds.
    - iii) McCormick is having issues with the new road height
      - a) He cannot exit his driveway with trailers and mail cannot be delivered to his mailbox per a conversation with the mail carrier.
      - b) He also noted that it was his understating that the passing lanes would be removed, but that they were put back in their original spots.
        - i) Burton said that removing the passing areas was considered. However, it was determined that removing passing lanes could lead to more incidence of reckless driving.
    - iv) Ogilvie made mention that there have been issues with signage along the roadways. Specifically, the signage for the Ironman caused confusion for people traveling to local businesses in the area.
      - a) Burton agreed and went over the corrections that the County is proposing for next year.
- 6) DISCUSSION ITEM

- a) Pacific Gas and Electric – Clay Merrill, Local Government Relations Representative
  - i) Mr. Merrill gave detailed information about Public Safety Power Shutoffs (PSPS)
  - ii) Ogilvie asked about the differences between the January 27<sup>th</sup> weather event which caused widespread outages and the atmospheric river in October that did not lead to outages
    - a) Patrick Ellis said that wind was a factor in the January event. He apologized for any lack of communication. He said over 100 poles were broken in that event. He also said that the event led to a lot of internal discussion.
      - i) The company decided to “harden” the poles with extra support wires and other methods replaced some wooden poles with metal ones
  - iii) Supervisor Villegas stressed the importance of some level of communication during an outage even if the answer is “We don’t know”
