#### 6. Provider Presentations

- Elise Rietz and Jeneba Lahai from Yolo County Children's Alliance (YCCA) presented on their program funded by CSBG. Reference the attached PowerPoint presentation for complete details. Presentation highlights include:
  - The YCCA Homeless Services Program Purposes:
    - To improve the lives of low-income persons who are unstably housed or experiencing homelessness in Yolo County by securing permanent housing placements.
    - Purpose: To improve the lives of low-income persons who are unstably housed or experiencing homelessness by increasing noncash benefits and increasing income.
  - Services provided include (1) provide housing and homeless case management services in Yolo County (2) serve as a point of entry for low income persons

requiring such services, with a special focus on West Sacramento, and (3) work collaboratively with the County and community partners to provide supportive services.

- The Homeless Services Program is based at the West Sacramento Family Resources Center. The program includes the Siemer Family Stability program, Project Roomkey, and Housing Navigation.
- 76 CSBG clients served to meet 80 clients by the end of year.
- 27 clients 27 clients have secured permanent housing (goal is 32 by Dec 2020)
- Currently open twice a week for walk in hours and available by phone five days a week.
- Currently CSBG case manager are working with Project Roomkey to provide onsite case management to 75 individuals.
- Bill Pride with Davis Community Meals and Housing (DCMH) presented on his program funded by CSBG. Presentation highlights include:
  - The DCMH Program Purpose: To provide low-income individuals and families with housing, food, and human services to help them rebuild their lives
  - DCMH started as a meals program about 30 years ago and expanded to provided housing and other services to homeless and low-income individuals.
  - Services have grown from prevention type services, e.g. providing food & clothing to provide more housing type services, e.g. transitional and permanent supportive housing. Some of the DCMH program include:
    - One program we run is the resource center operated Monday to Friday to provide shower, food, laundry, and case management services (benefit and housing applications, document gathering)
    - Street Outreach staff go to campsites and streets to build trust within the homeless community to link them to services
    - Housing programs
      - a. CSBG Family Transitional program at Owendale long term 24month program. Services provided include case management supportive services, life skills training, employment training and assist in finding PSH
      - b. H Street Adult Transitional Housing Program 18-month program. Services provided include case management supportive services, life skills training, employment training.
      - c. DCMH has tried to focus on PSH with building Cesar Chavez Park which is currently housing 44 individuals with special needs and with Creekside which is permanently affordable housing.

#### 7. Board Vacancies; Board Member Positions updates; Officer Nominations

There are three current vacancies – District 2 and two low income members. Some members' terms are expiring at the end of 2020 – Isaac, Bill, David, Manuela, Pamela Byrd-Dunns. Isaac and David have already reached out to their supervisors for reappointment. Officer terms are annual a new chair and co-chair will need to be nominated or volunteer.
