6. 2023 Q2 Performance Measure Report - Jacob Baker

• An overview of the Q2 Performance Measure for Yolo County Children's Alliance was presented. Highlights include exceeding their annual goal of individuals receiving housing related case management, individuals receiving housing resources and referrals, and increasing individuals' monthly income. In addition, they have exceeded their goal having individuals housed in less than 120 day and are 3/8ths of the way to their annual goal of 96 individuals being permanently housed. Questions were asked regarding timeliness of housing placement between quarters and why

they were varied-different numbers of clients each quarter; were clients duplicated in measure 3.2-Yes; For measure 3.3 does this total income include cash benefits—Measure 3.3 It is for all non-cash benefits Community Member asked about participants served and the goal being 24, but the actual served in the first quarter was 40 and they exceeded the goal so there isn't an ability to serve more and how is it factored and if there is a waiting list.—Yes there is a waitlist and the providers use coordinated entry, therefore when a spot opens up, more individuals are served. Community member asks if there was a rubric that is being used in terms of the equity factor for case management currently the ViSpdat is used but the local CoC has data subcommittees that are analyzing different tools to use in lieu of the ViSpdat. There was a recommendation by a community member to get the duplicated and unduplicated data to compare and separate the data for each quarter from providers.

• Q2 Performance Measure for Fourth and Hope was presented. Highlights include: 2 participants away from meeting their annual goal of participants served, served 41,600 meals, 16 participants have exited to stable housing, 2 participants have increased their income, they have exceeded their annual goal for participants accessing primary care and mental health services, while the goal for average length of stay is less than 90 days in this review period the average time is 229 days, the goal of inputting data into HMIS within 5 days was 100% achieved, the goal for client cases to case manager is exceeded (20:1); and 2 participants away from meeting their annual goal of 250 participants engaging in ongoing services. Questions were asked: Is there a way to compare clients from last year to see their progress and it would be useful on having the provider adding facility details because they have the Fourth and Hope emergency shelter and they have some limitations on who can stay there, and their Walter's House is a different structure

7. Request for Proposals (RFP) Update

Jacob will be emailing out the RFP and has made it clear what changes/updates
have been made for their review. Right now, they are working with the procurement
department to get the RFP updated and finalized. CSAB members will be the
evaluation panel and have a scoring sheet to review the RFP's. Kerrie mentioned
that is they need support to use the system online, they can reach us to assist them
if needed.

8. Board Vacancy Update

Jacob announced the following updates: Irma is now considered a Community Organization Representative; Roz is now moved to a Low-Income Representative. Jacob introduced Jocelyn to the Board who is a potential Low-Income Representative. Andy led the Board on voting, and it was unanimous, and Jocelyn is now officially a member of the Board. Jacob also mentioned we have inactive member that we are looking to remove. Vincent Olvera was removed with a unanimous decision. Roz brought up that Maria Elena Alvillar is in a nursing home

and can't serve anymore. Roz led the Board on voting, and it was unanimous to removing her from the Board.
