#### 7. Request for Proposals (RFP) Update

Jacob Baker reviewed the timeline for the Pre-Bid Conference and where we are in the process and important dates to keep in mind that are quickly approaching. The county will be using a website called Periscope S2G (Formerly BidSync) where they will be able to evaluate each provider to ensure they meet the requirements for the contract. Jacob mentioned that Karen Kawelmacher from Yolo County procurement department will be contacting them soon to make sure, they have the instructions and link to access website. The next step in the process for them will be September 21<sup>st</sup> for the Pre-Proposal Conference and the deadline for the written comments and questions posted on Periscope S2G is October 5<sup>th</sup>.

#### 8. CSBG 2022 Annual Report Update

 The annual report was reviewed for CSBG providers: Yolo County Children's Alliance (YCCA), Yolo Wayfarer Center (Fourth and Hope) and Davis Community Meals and Housing (DCMH) for the year 2022. Some highlights include: YCCA helped 76 individuals in avoiding eviction, Fourth and Hope assisted 265 unemployed adults in obtaining employment (up to a living wage), and also they helped 280 individuals obtain safe and affordable housing.

#### 9. 2022-23 CSBG Funding Update

• In January 2023, the Yolo County Health and Human Services Agency (HHSA) executed a contract of \$391,080.00 for 2023 Community Services Block Grant (CSBG) funds from the State of California, Department of Community Services and Development (CSD). \$96,549.00 was retained by HHSA for admin and staffing costs, while \$140,922.00 was utilized to maintain a housing and homeless "direct client" services emergent needs fund to help in rental assistance and other needs to keep clients in stable housing. The remaining amount of \$153,539.00 was awarded to Yolo County Children's Alliance \$100,000.00 and Fourth and Hope \$53,539.00. In June 2023, CSAB voted to give \$2,423.00 to YCCA and \$1,298.00 for Fourth and Hope which was additional funding awarded.

#### 10. Board Vacancy Update

- The Community Service Action Board Roster was reviewed, and Jacob addressed that Vincent Olvera was present in this meeting and informed him that in the August 8<sup>th</sup> meeting, he was removed from the board. However, Jacob mentioned he was going to reach out to see if he can be appointed to fill the Low-income representative if he commits to attending meetings at a regular basis.
- We are actively trying to fill the two Low-income representatives' appointments by having the Clerk of the Board of Supervisors' Office post fliers outside County Offices and outside the Board of Supervisors' Chambers, they also place advertisements in local newspapers. HHSA staff utilizes partnerships with local organizations to identify and recruit perspective members. They also developed and posted a press release seeking applications for CSAB, reaching an audience of 130 contacts/interested parties, 1,960 Yolo News e-subscribers, 13,363 Yolo County General Facebook, and 4,679 Twitter followers. Lasty, HHSA staff developed a flier exclusively to recruit Low-income CSAB member applicants.
