- TANA project's environmental analysis and bid package is complete and is currently out for bid. Bid closing ends January 12, 2009 and then construction should begin, once the contractor is selected.
- On ADMH, this Board just ratified the purchase of Meadowlark, the second home in West Sacramento, with design work just about done on Trinity and they are moving forward on this project.
- Met with the City of West Sacramento with their Housing Department and had a very
 productive meeting where they are looking for ways they can do more partnerships and look
 at how Yolo County Housing can help further some of their housing and community
 development initiatives.
- Contract with the City of Davis to provide contract compliance inspections for their HOME-funded units, which are not part of Yolo County Housing.
- Joe from the Maintenance Department and Connie from the social services department have been out but should be returning to work soon.
- YCH staff is a week and a half into their food drive for the Food Bank, and also participating in bell ringing outside Raley's for the Salvation Army.
- New orientation packets for all board members will be delivered in January, as well as NAHRO's second and revised handbooks and new YCH pins. They will be organizing a tour in February for new board members and any others interested.
