6. **HEALTH OFFICER UPDATE** – *Dr. Aimee Sisson, Health Officer*
 - Summary of the items covered in the presentation: Health Officer Update
 - Check vaccination status before travel, especially for children.
 - Children may need extra or early dose of MMR.
 - Important for providers to screen for latent TB in person with risk factors.
 - TB Health Alert coming soon.
 - CDC issued Health Advisory alerting healthcare providers to increase in invasive meningococcal disease.
 - Stay up to date with meningococcal vaccines.
 - CAHAN sent to Yolo providers.
 - Sacramento County resident recently died from lead poisoning.
 - Wastewater levels of SARS-CoV-2 are low.

- Hospitalizations for COVID-19 are low in CA and Yolo County
- RSV activity in Yolo County is Low
- Flu activity in Yolo is Low
- Flu vaccine or mask order in effect through April 30th, 2024

 - Contract is expiring.
 - Common Spirit purchased Dignity.

 - Must agree on rates.

 - Many state and local officials have their eyes on this issue.
- Budget update
 - A lot of unknowns with budget. We are mostly grants and allocations so feeling good.

 - Still waiting on state budget.
