Re: Meeting Their Obligations? A Report of Yolo County Detention Facilities – Yolo County Grand Jury 2022-23 Consolidated Report

Grand Jury Foreperson and the Honorable Daniel M. Wolk:

The following is the response of the Yolo County Sheriff's Office ("Sheriff's Office") to the Grand Jury's request for additional information or evidence of implementation of the following recommendations:

R-2: The Yolo County Sheriff's Office should further research RFID systems for compatibility with their facilities and, if found to be compatible, by April 1, 2024, submit a request to the Yolo County Board of Supervisors to invest in this technology.

The recommendation has not yet been implemented but will be implemented in the future. The Sheriff's Office has initiated contact with vendors and is in the beginning stages of project exploration.

R-3: The Yolo County Sheriff's Office should submit a report to the Grand Jury by January 1, 2024, regarding the status of its full implementation of the JMS and RMS systems, including the online video visitation/scheduling and grievance management systems. The Yolo County Sheriff's Office should send an update report to the Grand Jury every six months thereafter until all systems are fully implemented.

Video visitation, online scheduling, and electronic grievance management systems are now live. These systems are not dependent on the implementation of new a Records Management System (RMS) and/or Jail Management System (JMS).

The Sheriff's Office has made the decision to cancel the contract with our RMS/JMS vendor due their inability to meet contractual obligations which was the cause of the continual delays. This project remains a high priority and a Request For Proposals will be released in the next year in order to select a new vendor.
