- 6) COUNTY UPDATE JD Trebec provided the following updates.
 - a) Orciouli final map could be soon.
 - b) G. Moris asked about E. Parker. Development agreement expires at the end of the year. That agreement currently includes a gas station.
 - c) J. Hulsman inquired about the Solar Farm? JD hasn't heard anything.
- 7) INFORMATIONAL ITEM (none)
- 8) ACTION ITEMS
 - a) Recommendation for the proposed street names for the Orciuoli and Story subdivisions

- i) Back in the 90's a citizen of Yolo County sent a letter asking streets to be named after pioneers. JD's concern is that the Planning Commission has been handing it out, which some may think it implies that it has been vetted or a County policy is in agreement with it.
- ii) JD presented the list. Some names are already used. Talked to developer already about substituting Campbell for Stephens.
- iii) Jack Regarding the Story subdivision, has the Durst family been asked if using their name is OK? J. Hulsman pointed out for family names, depending who you ask, you may get different answers.
- iv) JD read the letter from the Tribe objecting to a number of names on the list and providing a list of Patwin names for consideration.
- v) The committee members expressed concern that many of the names have difficult spellings and pronunciations
- vi) The pros and cons of various names were discussed as was including the name of a pioneer woman. It may be better to pick names that are not people.
 - (1) G. Moris suggested using names of plants and animals.
 - (2) P. Harrison suggest we come up with a slate of names.
 - (3) Local orchard crop names were suggested: Almond, Pistachio, Walnut, Olive
- vii) **Motion** by G. Moris regarding Orciuoli streets, to rename Barnes to Olive, Fredson to Almond, Nissen to Pistachio, McHenry to Walnut, and have the Campbell name extend through Wintun. Second by S. Reed.
