PROJECT DESCRIPTION


The Home Energy Score (HES) pilot program is a voluntary initiative targeting homes in the unincorporated areas of Yolo County. Utilizing the Department of Energy scoring system, the program aims to encourage upgrades through energy assessments, toolkits, and educational efforts for realtors and assessors, with financial support for low-income households.

Energy-efficient upgrades improve home comfort by maintaining consistent temperatures and eliminating drafts and hot spots.




Property Value

Reducing a home's energy consumption lowers its carbon footprint, contributing to environmental preservation and supporting global efforts against climate change.




Resilience & Sustainability

HOW HES WORK?

The Home Energy Score simplifies home energy efficiency into a single, comparable number using a 1 to 10 scale.





Date Collection

- Evaluates 50 characteristics related to energy use.
- Key factors include insulation, HVAC, and more.



Scoring System

- Scale from 1 to 10 based on efficiency.
- Accounts for local climate impacts.



Outcomes & Benefits


- Offers estimates on energy costs and savings.
- Recommends upgrades to enhance efficiency and property value.

PROJECT DESCRIPTION

The Weatherization Program stems from community feedback during the 2023 CAAP workshops, aims to enhance home energy efficiency through DIY solutions. The program will provide kits for targeted insulation improvements and energy cost reduction.

Weatherization Kits

Kits may include:

- Weatherstrips
- LED Light Bulbs
- Window Insulation
- Door Sweep
- Water Leak Detection Tablets
- Door Sweep
- Installation Guide Sheet
- Energy Saving Tips Booklet


Education

WHAT ARE THE COUNTY'S HOME ENERGY EFFICIENCY PROGRAM?

Yolo County is launching an exciting outreach initiative focused on two key home energy efficiency programs: the **Home Energy Score (HES) Pilot Program** and the **Weatherization Program.** These programs aim to improve home energy efficiency, reduce energy costs, and enhance living conditions for our rural, low-income homeowners and renters. We are seeking dedicated CBOs to help implement these programs in the rural and unincorporated areas of Yolo County, particularly targeting low-income, elderly, and renter populations.

PROGRAM GOALS:

<u>Home Energy Score (HES) Pilot Program:</u> This program offers community members a voluntary energy assessment by trained technicians, producing a score and recommendations for improving energy efficiency. The pilot will cover up to 50 homes, focusing on low-income homeowners and multifamily properties.

Weatherization Program: Designed to equip low-income households and renters with free DIY weatherization kits, this program empowers community members to independently improve their homes' energy efficiency. The kits include tools, resources, and educational materials to guide effective usage.

COMPENSATION & TIME COMMITTMENT

Compensation for the selected Community Based Organizations/Partners will be \$8,000.

Monthly meetings are **60 minutes.** Review of materials in advance of the monthly meeting and coordination in between monthly meetings is also anticipated. It is also expected that CBPs/CBOs will **support coordination and/or attend community events throughout program duration**. CBOs/CBPs may spend **2 to 4 hours per month** on average from Fall 2024 through Winter 2026.

REQUEST AND EXPECTED OUTCOMES

Yolo County is looking for three Community Based Partners (CBPs) and/or Community Based Organizations (CBOs) to **build and maintain relationships with the community in the unincorporated area of Yolo County** throughout the Home Energy Efficiency Program duration. By working with CBPs/CBOs that are known and trusted within the community, the County hopes to center equity in the outreach and engagement process and ensure the program reaches low-income, elderly, disabled residents, and renters, while creating opportunities for economic and social well-being.

Serving as an Outreach Partner entails the following:

- Attendance at monthly meetings
- Coordinating and/or facilitating community event(s) related to the Home Energy Efficiency Program, i.e. workshops, tabling events, convening community conversations, etc.
- Providing input on the Equity and Engagement Strategies used for community outreach and engagement.
- Providing input on materials and tools used for community outreach and engagement.

If possible, please describe your ability to provide services in multiple languages (particularly, Spanish) to ensure effective communication and engagement with diverse community members.
