
A roll call for voting members was taken, guorum was not met.

- 3. Vote on Approval of MAY 09TH, 2024 Agenda and the April 11th, 2024 Minutes Anthony Volkar, Chair Quorum not met. Will vote on approval at June Health Council meeting.
- 4. STATE AND COUNTY UPDATE Mark Bryan, Deputy Chief Administrative Officer
 - State budget
 - Early budget deal
 - Fiscal year ends 6/30/24
- 5. Board of Supervisors Update Deputy Supervisor Sheila Allen, District 4
 - Adult Day Healthcare moving to Norton Hall.
 - Nolan Sullivan represented HHSA well at BOS meeting regarding Partnership and Dignity negotiations.
 - 5 counties are affected by Partnership and Dignity decisions.
 - Mental Health patients are still able to continue with continuity of care only for issues that were previously treated.
 - Partnership has identified a list of members who might fall into category of continuity of care and have had contact with these members.
- **6. HEALTH OFFICER UPDATE** *Dr. Aimee Sisson, Health Officer*
 - Avian influenza, aka bird flu, aka H5N1
 - Widespread in wild birds worldwide
 - Sporadic detections in U.S. mammals
 - Outbreaks in U.S. poultry since 2022

- Spread to U.S. dairy cows by January 2024
- Pasteurized milk is safe. Raw milk is not safe.
- Cow to cow transmission is likely.
- Some infected cows may be asymptomatic.
- FDA and USDA found avian influenza viral particles in 20% of pasteurized milk.
- Raw milk is not pasteurized.
- Sale of raw milk is legal in California, regulated by CDFA.
- Avian influenza has spread from cows to at least one person. A human in early April in a Texas dairy.
- Testing in cows is increasing, but more is needed in cows and in people.
- Yolo County has very little dairy activity.
 - One dairy off highway 505 between Winters and Woodland.
 - Small dairy herd on UC Davis Campus.
- Avian influenza tracked in wastewater as part of Influenza A.
- Current flu A levels are low across Yolo County.
- CDC believes the current risk to the general public from bird flu is low.
- Public Health following situation closely, collaborating with Agricultural Commissioner.
- Public Health will monitor any persons exposed to infected dairy cows for symptoms.
- Seasonal flu vaccinate or mask order ended April 30th.

9. YOLO FOOD BANK - Genevieve Pyeatt, Director of Programs

- Completed a population-based survey to gather date for Yolo County.
- California has the highest poverty rate at 13.2 %.
- Out of 58 counties in California, Yolo County is the most impoverished with a poverty rate of 19.5%.
- In California the household food insecurity rate is 22%.
- At 29.2% nearly 1 in 3 households are food insecure in Yolo County.
- A staggering 52.9% of households working in the agriculture industry are food insecure in Yolo County.
- 40% of households have children and nearly 20% have house households with seniors.

- Over half of the houses surveyed reported using charitable food services frequently or very frequently (55.2%).
- 64.1% reported they gave food they received to family and friends.
- In Yolo County 18.9% of respondents reported utilizing Cal Fresh.
- In 2023 43.6% cited they obtained nearly all or all of their household food through Cal Fresh.
- This survey is a remarkable example of how food banks can use data to better understand food insecurity in their communities.
