## **Emergency Medical Services and Emergency Preparedness**

#### Data/analytics requests:

- Provided life expectancy and leading cause of death data on Westfield/Evergreen (in West Sacramento) for Supervisor Villegas' request.
- Provided updated summary of syphilis epidemiology in Yolo County for the Syphilis Control Plan.
- Provided a statistical model of risk factors for congenital syphilis in Yolo County
- Provided data on cigarette usage and prenatal care visits for mothers in the MCAH population from 2019-2023.

#### Support for Infectious Disease Control programs:

- Continuing to support LTCF outbreak teams with outbreak tracking and report generation for COVID and influenza outbreaks.
- Continuing to assist the Communicable Disease team with ongoing carbapenem-resistant Acinetobacter baumannii (CRAB) outbreak.
- Assisted the Communicable Disease team with yet *another* measles contact investigation.
- Finalized the avian influenza contact investigation and outbreak tracking workbooks for the Communicable Disease team.
- Medical records supported CD and LTCF teams by processing faxed reports and submitting initial medical record requests and 111 follow-up requests.

• Continuing to track inadequacy of new Kaiser communicable disease reporting and collaborating to improve reporting reliability and reduce both missing data and unreported diseases.

#### Support for the farmworker study:

 Provided summary statistics on the Farmworker Survey for Esmeralda that compares Yolo County's FWs with Yolo County overall, the UC Merced FW study, and the UC Santa Barbara FW study from 2020-2023, presented at All-Staff.

#### Support for the MCAH program:

• Assisted with completion of MCAH Title V Needs Assessment submitted to the state for YC's 5-year MCAH plan.

#### Other ongoing projects:

- Major progress identifying all vaccine data for Yolo County in CAIR.
- Major medical record review project for Yolo County syphilis cases for approximately 1,000 disease incidents with 103 additional medical record requests.
- Continued maintenance of the integrity of state CAIR and CaIREDIE databases with 223 CaIREDIE master patient index merges and 13 CAIR account merges.
- Contributed to the Public Health Alliance's *Empowering Small and Rural Jurisdictions: Addressing Data Gaps and Advancing Equity* recommendation.
- Continuing to develop recommendations for population denominator data as part of the CDPH Population Task Force.

#### **NEW!-Talk Saves Lives**

• Talk Saves Lives<sup>™</sup>, created by The American Foundation for Suicide Prevention (AFSP), is a standardized 45–60-minute education program that provides participants with a clear understanding of this leading cause of death, including the most up-to-date research on suicide prevention, and what they can do in their communities to save lives. No pre-work required.

• July 30<sup>th</sup> (9:00 a.m. - 11:00 a.m.)

#### Suicide Prevention in the Workplace

- This training is 2 hours in length and includes videos, group • discussions/exercises and roleplays to create a better understanding of your role in suicide prevention. No pre-work required.
  - July 16<sup>th</sup> (9:00 a.m. 11:30 a.m.)

#### QPR (Question, Persuade, Refer)

- QPR is a 2-hour suicide prevention training. The mission is to reduce suicidal behaviors and save lives by providing innovative, practical, and proven suicide prevention training. The signs of crisis are all around us. We believe that quality education empowers all people, regardless of their background, to make a positive difference in the life of someone they know. No pre-work required.

#### Mental Health First Aid

- Youth Mental Health First Aid is designed to teach parents, family members, caregivers, teachers, school staff, peers, neighbors, health and human services workers, and other caring citizens how to help an adolescent (age 12-18) who is experiencing a mental health or addictions challenge or is in crisis. Please Note: This training has a 2-hour. selfpaced pre-work that needs to be completed before the training.
  - July 18<sup>th</sup> (8:30 a.m. 3:00 p.m.)

#### Adult MHFA

- Is a course that teaches you how to identify, understand and respond to sign of mental illness and substance use disorders. The training gives you the skills you need to reach out and provide initial help and support to someone who may be developing a mental health or substance use problem or experiencing a crisis.
- Please Note: This training has a 2-hour, self-paced pre-work that needs to be completed before the training.

## Maternal, Child, and Adolescent Health Program (MCAH)

- The MCAH Team submitted the 5-year Local Title V Needs Assessment and Children and Youth with Special Health Care Needs (CYSHCN) Systems Capacity Assessment on June 27<sup>th</sup>. This process allows LHJs to conduct a local needs assessment to determine the strengths and weaknesses of the local public health system and to determine priority areas for the MCAH population for the next 5 years.
- The Local Title V Needs Assessment informs the State Title V Needs Assessment, which helps CDPH and the MCAH branch to develop a 5year State Action Plan, which will eventually inform the development of the local MCAH Scope of Work.

#### **Comprehensive Perinatal Services Program (CPSP**

## Health Equity and Healthy Communities

- The CalFresh Healthy Living (CFHL) Program led efforts to help get the Center for Land-Based Learning's Mobile Farmers' Market to have a site at the HHSA buildings in Davis, and that project kicked off on 6/5/24. CFHL also tabled and provided nutrition education and recipes to 50 market attendees.
- Two CFHL staff attended the Food, Mood, and Substance Use: Promoting Rural Wellness Symposium in San Diego on 6/13 and 6/14
- CFHL hosted a Successful quarterly Community Nutrition Action Partnership meeting on 6/27 with a diverse agency representation in attendance and 12 participants.
- The Healthy Yolo Team held 1:1 system mapping interviews with 9 community partners who provide services to kids 0-5 and their families to better understand the strengths/bright spots in service delivery and care continuums and challenges/pain points that impact access to services for families. This data, in conjunction with data gathered from the community, will be used to help the Healthy Yolo collaborative identify interventions and next steps to address root causes of disparities affecting families w/young kids.

## Infectious Disease Control

#### Immunizations:

- In June, coordinated with California Department of Public Health and Davis Pride organizers to offer MPOX vaccines at Davis Pride on June 1, where seven people were vaccinated.
- Yolo County Public Health Immunizations staff offered MPOX vaccines at Woodland Pride on June 22<sup>nd</sup>. While nobody was vaccinated, the staff at the even were able to share information with a number of residents about MPOX and sexual health.
- Using doses received through the Bridge Access Program (BAP), the team offered COVID vaccines at the Yolo County Jail on June 7 and 21. A total of 17 doses were administered.
- BAP-supplied COVID vaccines were also offered at the Madison Migrant Center on June 18.
- In coordination with Washington Unified School District and Woodland Joint Unified School District, the team is planning to hold Catch-Up Clinics in August for school-aged children who may have missed required vaccines due to the Dignity-Partnership issues this spring.
- Fall Seasonal Influenza Vaccine clinic planning is underway.

#### **Community Support & Collaboration:**

- Healthy Schools Collaborative (HSC) is on hiatus for Summer will continue sending monthly information sharing email sharing public health updates on 1<sup>st</sup> Wednesday to HSC members and summer school points of contact.
- Primary Prevention tabled at Davis Pride on 06/01 and distributed condoms, lube, STI Prevention Resources, and COVID Test kits.
- In June, Primary Prevention collaborated with:
  - Jail Health to inform Jail Health routine screening, treatment, and discharge planning.
  - UC Davis Student Health & CommuniCare+OLE to inform print material needs for PrEP & PEP education.
  - Yolo Mental Health Forensics on sock donations for vending machines & discussed how to seek communicable disease consultation for clients.
  - Yolo Cultural Competence to share LGBTQ/Pride resources and communications.

#### **Sexually Transmitted Infection Prevention:**

- Yolo County and the California Department of Public Health has executed the PrEP & PEP Initiation and Retention (PPIR) Initiative contract, aimed at increasing HIV PrEP and PEP use among people diagnosed with STIs and their partners, youth, and people involved in the carceral system. Current activities include compilation of a comprehensive pharmacy list that denotes what HIV PEP, PrEP, and Treatment medications are stocked and production of print materials to educate the community on program confidentiality and PEP/PrEP.
- The Syphilis Task Force presented to the Health Council at the June meeting and has made inroads to complete the DRAFT Syphilis Response Plan, upon the documents distribution a new meeting schedule will be established. Additionally, <u>NEW DoxyPrEP</u> <u>Guidelines</u> were shared with Task Force Members.
- Take Me Home pilot, (4) residents requested test kits this month, and (4) resulted all negative. The county pilot allocation of test kits is below 10. To request tests visit: <u>www.takemehome.org</u>
- In June, Communicable Disease Investigators investigated reports of the following infections:
  - o 57 chlamydia
  - $\circ$  15 gonorrhea
  - o 27 syphilis

#### Tuberculosis

• Yolo County received 11 reports of suspect or confirmed Tuberculosis (TB) in June. The TB Public Health Nurse, in cooperation with the Health Officer and Sacramento County, continue to manage active cases reported in previous months.

#### Outbreaks

• Communicable Disease Investigators monitored new and ongoing outbreaks of COVID-19 and influenza in long-term care facilities. The Communicable Disease team also monitored an outbreak of hand, foot, and mouth disease at an elementary school.

#### Measles

 The Communicable Disease team learned of a suspect measles case in an infant on May 21<sup>st</sup>. The infant, as well as a second case, were confirmed the same day. Both infants had recently returned from international travel. Contact tracing conducted by staff identified Kaiser Permanent South Sacramento Emergency Department and Kaiser Permanente Downtown Commons Pediatric Clinic as possible sites of exposure to other individuals. In coordination with Kaiser, the Yolo team identified and contacted all patients who may have been exposed, along with any other individuals who accompanied them to visits, in order to provide PEP guidance and symptom monitoring. So far, no secondary cases of measles have occurred.

#### Avian Influenza

• The team continues to stay abreast of guidance and situational updates from the CDC and CDPH.

#### Other reportable communicable diseases

 Excluding cases of COVID-19 and STIs, Yolo County received eLRs or CMRs for the following diseases in June. Staff review case reports and determine if cases are new (ruling out previously reported cases, out of jurisdiction, and unconfirmed), and determine if reports meet case definitions. When case definition is met, investigators verify treatment, and interview cases and their contacts as appropriate. In addition to new reports, CD staff carry a case load of previously reported cases that require ongoing investigation to ensure appropriate treatment. \*Please note that numbers represent reports, not confirmed cases. Reports of priority conditions are investigated to know if cases are new, confirmed cases and require follow up:

- Less than 11 coccidioidomycosis

### Health Education

#### Friday Night Live / Club Live

- Friday Night Live / Club Live programs are on summer break. Many Yolo County high schools and middle schools will start the second week of August.
- Friday Night Live / Club Live staff have attended a series of webinars and trainings on Responsible Beverage Service (RBS) programs in effort to have Yolo County Public Health offer this education and certification at nocost to alcohol servers in Yolo County.
- Effective July 1, 2022, RBS training education is required by CA Assembly Bill 1221 and Assembly Bill 82 for on-premises alcoholic beverage servers and their managers.
- All Friday Night Live / Club Live staff have completed the RBS Train the Trainers training.
- Yolo County Friday Night Live Programs have submitted an RBS Training Curriculum program application to the California Department of Alcohol Beverage Control (ABC) for approval.
- Once the application is approved, Yolo County Public Health can begin offering RBS training to alcoholic beverage servers at on-premises ABC

licensed locations, such as bars, restaurants, tasing rooms, hotels, caterers, etc.

#### **Tobacco Prevention Program**

- The results of our Tobacco Endgame Smoke-free Outdoors observations were formatted by the California Tobacco Control Evaluation Center and sent back to us for analysis. Once analyzed, the results will be used to complete our Stop Commercial Tobacco Endgame objectives. The data was collected by staff last spring in the city of Winters. Observations help determine the amount of tobacco use in a variety of public outdoor locations.
- The Smoke-free outdoors Winters workgroup scheduled a meeting with one member of the Winters City Council to discus the need for smoke-free public outdoor locations in Winters. Multiple educational materials previously created by staff, were presented to the City Council member during the meeting. The materials demonstrated the dangers of exposure to secondhand smoke, the survey results supporting smoke-free policies by Winters residents, and sample policy language. The City Council member agreed to introduce the topic during the July Winters City Council meeting to request support from other members and to put the item on a future meeting agenda.
- Staff recruited two Woodland High School students to participate as interns. The internship program is a required component of the Tobacco Prevention program with the purpose of giving young people opportunities to gain exposure and experience to public health and policy development aspects. The inters will participate in an variety of program activities including, developing social media posts, acting as decoys for youth purchase surveys, and attending activities that educate elected officials.

#### **Tobacco Enforcement Program**

 In June, the Tobacco Enforcement Program conducted 17 retailer compliance checks and licensing inspections to help tobacco retailers identify ambiguously labeled flavored tobacco products. Several stores were found ito be selling flavored tobacco products and were issued warnings. Staff also conducted an undercover decoy operation attempting to purchase illegal products in retailers that had already received warnings. Unfortunately, two stores were discovered still selling flavored tobacco products. The process to revoke their licenses is currently underway.

#### **Traffic Safety**

The Traffic Safety Team accomplished several key objectives in June, which include:

- Attended a Crossing Guard Training Program hosted by the CDPH Active Transportation Safety Program
- Hosted a 3-day League of American Bicyclist League Cycling Instructor (LCI) seminar, during which 8 participants received certification.
- Wesley Yang became a certified League Cycling Instructor
- Gabriela Palomares and Johana Ayala completed the Safe Travel for All Children: Transporting Children with Special Health Care Needs course and obtained certification to work with children with special health care needs.
- Recycled 60 car seats
