- Commission members discussed their thoughts and suggestions on the Draft CAAP:
 - Commission members discussed the structure and content of the CAAP, highlighting the need for accessible communication strategies, including videos and social media engagement, especially targeting youth and non-English speakers.
 - The need to broaden the focus beyond just farmworkers to include all outdoor workers and other impacted communities was highlighted, ensuring that the CAAP addresses the needs of all vulnerable groups within the community was discussed.
 - Suggestions were made to simplify the CAAP by reducing bureaucratic language, rearranging chapters to improve clarity, and enhancing visual components for better engagement.
 - When reordering chapters, a suggestion was made to place mitigation strategies upfront, while technical and appendiceal content might be better positioned towards the end.
 - There was concern about the document being too wordy and suggestions to convert tables into figures for better understanding of the CAAP.
 - Discussion on how the CAAP should be structured like a business proposal, with clear sections on introduction, strategies, finances, monitoring, and implementation.
 - The importance of an effective executive summary and clear implementation strategies was emphasized, with suggestions to create separate documents detailing the CAAP's objectives and technical aspects.
 - Highlighted the need for engaging with different community stakeholders, including youth and local artists, to disseminate the CAAP effectively.
 - Discussion on the importance of implementation strategies and potential challenges, with suggestions for a detailed executive summary and a phased approach.
 - The need for a clear indication of the difficulty of implementing various measures within the CAAP, helping to prioritize actions based on feasibility was mentioned. Staff responded that action phasing criteria were created for this purpose.

- There was a focus on improving how data is gathered and presented in the CAAP. Suggested that the CAAP should include a detailed section explaining how data was collected, emphasizing the need for transparency and clarity in data presentation to enhance stakeholder trust and understanding.
- Comments were made on the challenges of accurately capturing emissions data, particularly concerning the impact of drought on the 2022 emissions inventory and the exclusion of mining operations from the inventory.
- A recommendation was made to embed links within the CAAP for deeper dives into specific recommendations and to ensure active involvement during the implementation phase.
- There was considerable discussion about the uncertainty of future funding for climate action initiatives. Concerns were voiced about relying on increasingly scarce federal and state resources and highlighted the need to prioritize plans that can capture as much emission reduction as possible.

Public Comment:

- Public comments raised issues with the equity focus of the CAAP the use of ARP funding and the inclusion of vulnerable communities.
 Noted flawed definition of "just transition".
- A community member suggested making a new chapter specifically for 'clean energy' as energy is only mentioned in Strategy 3: Decarbonize Energy and Buildings and Increase Energy Efficiency; there are no sourcing in the CAAP for clean energy.

RECOMMENDED ACTION

1. Receive Update on 2030 Climate Action and Adaptation Plan Community Workshop Series #3 and Total Number of Engagement Events.

REASON FOR RECOMMENDED ACTION

County staff and the Yolo County Climate Action Commission ('Commission') are nearing the completion of the Climate Action and Adaptation Plan ('CAAP') update, with a net-negative greenhouse gas ('GHG') emissions goal by 2030. The DRAFT 2030 CAAP was released for Public Comment from June 7th, 2024 (12:00 AM) to July 10th, 2024 (11:59 PM) through a digital Public Comment Portal. In addition to the Public Comment Portal, County staff in partnership with the De Colores Resource Center ('De Colores') and Equity and Engagement Technical Advisory Committee ('E&E TAC')hosted six DRAFT CAAP Community Workshops (three in-person and three virtual) where community members could provide feedback, ask questions, and engage with various parts of the CAAP.

The six CAAP Community Workshops took place in June 2024 and served as the third installment of the CAAP Workshop series that began in June of 2023. Because the Commission is playing a large role in steering the development of the 2030 CAAP and has a vested interest in equitable community engagement during the planning process, it is important that all Commission Members are aware of the outreach conducted, what has resulted from it, and next steps.

BACKGROUND

The Yolo County CAAP is extremely ambitious – pursuing a net negative GHG reduction status by 2030 ahead of the State's goal of net-zero GHG emissions reductions status by 2050. The Yolo County Sustainability Division, Commission, E&E

TAC, County Community-based Organizations, and volunteers have now completed a total of three rounds of public feedback workshops to hear the community's feedback on critical elements of the CAAP.

- April 2023: County begins hosting public education and outreach events to solicit input on CAAP strategies and priorities.
- June 2023: County hosts the first 3 CAAP Community Workshops (one in-person and two virtual) to solicit input on key climate impacts facing Yolo County community members. A total of ~35 community members attended the three workshops and a total of ~400 completed a preliminary survey that was distributed at the workshops, community tabling events, online distribution systems (newsletters, newspaper ads, Instagram, Facebook, etc.) to also encourage community members to provide their input on their experience with climate impacts and potential actions that the County and individuals could take to reduce emissions. Spanish translation support was available for this workshop series.
- August November 2023: County continues to host public education and outreach events to solicit input on CAAP Actions through an extended survey where there were ~600 community responses.
- November 2023 January 2024: County hosts its second round of CAAP Community Workshops (9 in-person and 2 virtual) across the County at strategic locations to solicit hyper-local feedback on specific CAAP Strategies, Measures, and Actions. Over ~165 community members across the second workshop series were in attendance. Spanish translation support was provided from De Colores at this workshop series.
- April 2024 June 2024: County staff attends public outreach events throughout the County to inform the community of upcoming workshops for the DRAFT CAAP that was released for Public Comment on June 7, 2024 and would close on July 10th, 2023.
- June 2024: County staff host the third and final round of workshops(3 in-person and 3 virtual) for community engagement and feedback on the DRAFT CAAP. A total of ~11 community members attended workshop series #3. Spanish translation support and a fully Spanish-speaking workshop were made possible due to support from De Colores.
- Ongoing Throughout the Development of the CAAP: Staff have conducted targeted outreach in an effort to center equity, a Just Transition, and engage all community members in the CAAP development process, attending over 34 tabling events, receiving over 1,000 survey responses from the community (whereas the former response rate for the County was ~67 survey responses), presenting at 23 public meetings, and hosting three series of CAAP Community Workshops (13 total in-person and 7 virtual) where ~211 community members total attended CAAP Public Workshops.

Community Compensation

DRAFT CAAP Public Workshop guests were provided with free dinner and childcare to both encourage and thank participation in an effort to reduce barriers to participation in public processes. This not only directly benefited attendees but also highlighted and supported local Yolo County caterers (Las Maracas in Knights Landing and Hog Canyon Deli in Esparto), who received well-deserved recognition during the Workshops and through social media posts on our Sustainability Instagram and Facebook accounts.

Equity + Accessibility Focus

The CAAP Community Series #3 Workshops provided engagement materials in both English and Spanish and had Spanish translators from De Colores on site to serve as facilitators. In addition, the Esparto Workshop was hosted in Spanish only.

Workshop Series #3 Structure

At each Workshop were four themed boards organized by groupings of the 10 CAAP Strategies.

- Board #1 Transportation & Buildings
 - Strategy 1 Decarbonize Transportation (DT)
 - Strategy 2 Reduce Vehicle Miles Traveled (VMT)
 - Strategy 3 Decarbonize Energy and Buildings and Increase Energy Efficiency (EB)
- Board #2 Water & Waste
 - Strategy 4 Optimize Water Use (W)
 - Strategy 5 Minimize Waste (SW)
- Board #3 Natural & Working Lands

- Strategy 6 Reduce Off-Road Equipment Emissions (OFR)
- Strategy 7 Support Climate-Smart Agriculture (AG)
- Strategy 8 Sequester and Store Carbon in Natural and Working Lands (NWL)
- Board #4 Sustainable Consumption, Resilient Infrastructure, and Healthy Communities
 - Strategy 9 Reduce Carbon Footprint of Consumption and Production (RCP)
 - Strategy 10 Build Resilient Infrastructure and Healthy Communities (HC)

Each board was adorned with cards that presented the unique measures associated with each of the 10 CAAP Strategies. Consult the image below to view three of the four boards and their strategy cards in both English (two left most columns of each board) and Spanish (two right most columns of each board).



Guests were then encouraged to visit the boards that interested them, engage in conversations with County staff and facilitator's (De Colores Resource Center Staff and E&E TAC Members) and provide feedback (in the form of questions, concerns, criticisms, etc.) on the measures of interest. County staff and facilitators collected and/or recorded all comments made by guests.

Feedback

At the CAAP Community Workshop Series #3, attendees expressed several key themes in their feedback and questions:

1. Community Resilience Centers: The need for community resilience and cooling centers was a key concern to residents, particularly those close with the farmer and farmworker communities. There is a growing concern around the lack of opportunity farmers have to air conditioning during extreme heat. After working outside in extreme heat, many do not have access to air conditioning after their

- shifts, thus never having the opportunity to cool off which poses extreme health risks to our most vulnerable communities.
- Community Benefits: Participants wanted to understand how electrification (of facilities, the County fleet, etc.) would positively impact the community.
- **3. Green Initiatives:** There were concerns about the authenticity of green initiatives, with examples like diesel generators being used to power electric bikes.
- 4. Challenges in Rural Areas: Residents in rural areas highlighted difficulties in reducing mileage driven and expressed a need for more direct public transportation options. They also questioned how successful electric vehicles would be in rural areas due to concerns about cost, mapping of ZEV infrastructure, and geographical distance that would impact the cost of electric vehicle infrastructure.
- **5. Energy Efficiency Programs:** Some found energy efficiency programs challenging to navigate due to complex requirements. Specific issues included the need for costly roof repairs to install solar panels, even when the roof still had significant life left.

NEXT STEPS

All comments made at each workshop were logged into the Sustainability Division's Public Comment Tracking spreadsheet, sorted by type (Question/Clarification, Criticism/Complaint, Recognition/Appreciation, Concern/Caution, Correction, or Suggestion/Idea) and assessed on whether they warrant a change in the CAAP. Comments that were determined to warrant a change in the CAAP are in the process of being incorporated as appropriate. The revised and Final CAAP is scheduled to be adopted by the Yolo County Board of Supervisors in December 2024. Following the adoption of the CAAP, marking the start of CAAP implementation, County staff will continue to share outreach metrics, continue collaborative work with Community Based Organizations, and continue to improve our outreach efforts to serve as a model of an equity-centered public process for other jurisdictions.
