JUVENILE JUSTICE COORDINATING COUNCIL (JJCC)

- Purpose: Required to receive Juvenile Justice Crime Prevention Act and Youthful Offender Block Grant funding
- Primary Charge: Develop a continuum of county-based responses to juvenile crime
- Outcome: Comprehensive Multi-Agency Juvenile Justice Plan
 - Reviewed and revised annually
 - Submitted to BSCC by May 1 annually

- Enhanced Yolo County Charge: Advise the Probation Department on a variety of juvenile justice-related topics

JUVENILE JUSTICE REALIGNMENT SUBCOMMITTEE

- **Purpose:** Required to receive Juvenile Justice Realignment Block Grant funds
- **Juvenile Justice Realignment:** Shifts responsibility for youth court-ordered to the state-run Division of Juvenile Justice (DJJ) to counties, which started on July 1, 2021
- **Primary Charge:** Develop a plan to provide appropriate rehabilitation and supervision services of population previously served by DJJ that were realigned to county-run SYTF
 - Reviewed and revised annually
 - Submitted to OYCR by May 1 annually

 - Approve Bylaws

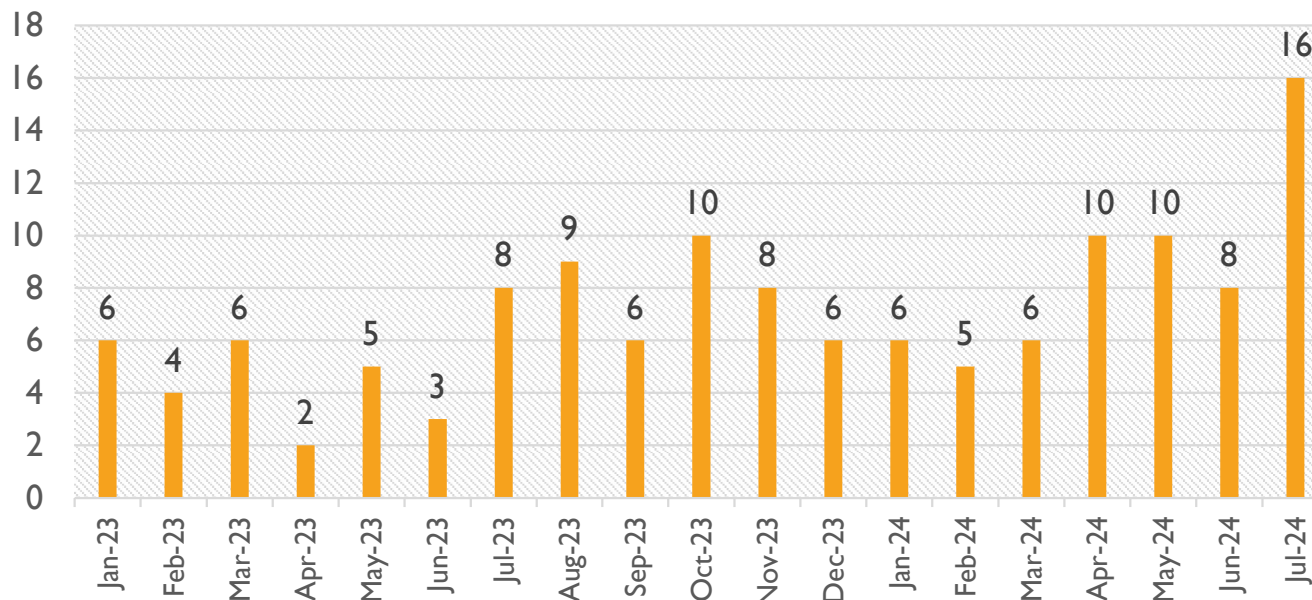
- CMJJP & JRBGP Submission: NLT May 1, 2025

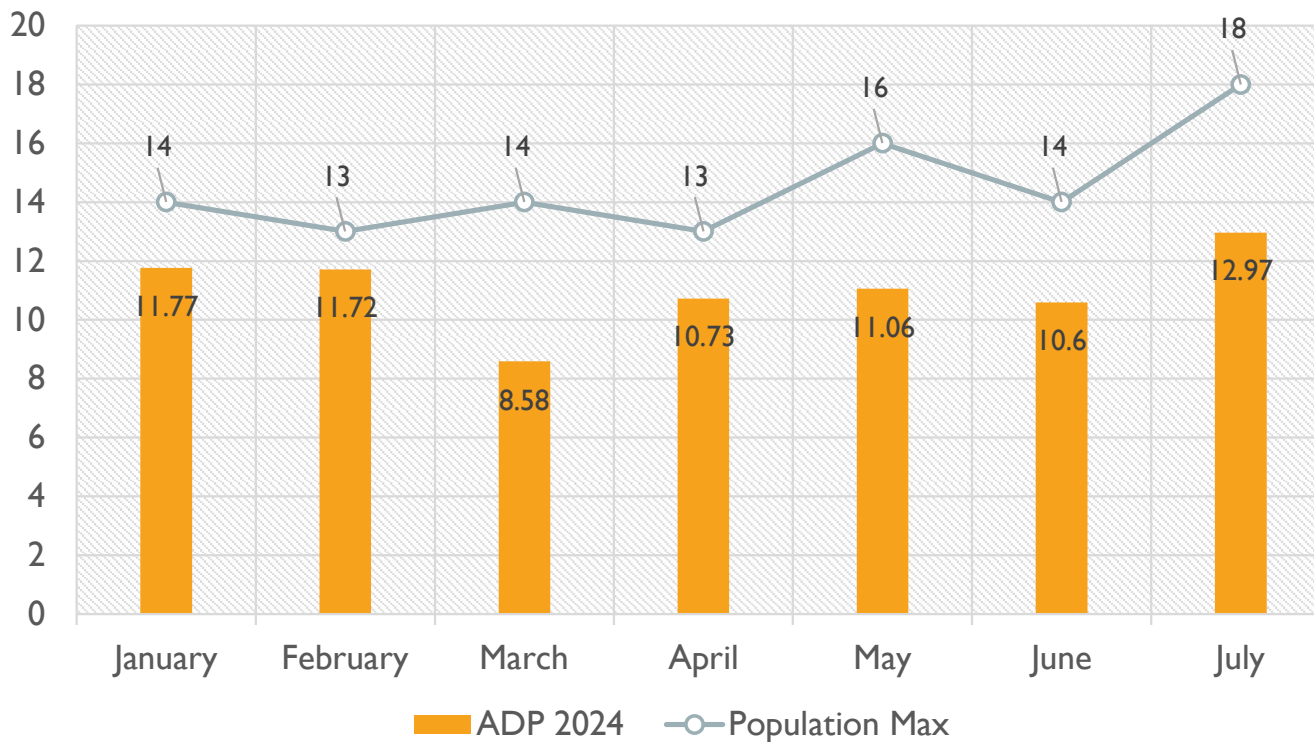

Juvenile Bookings by month



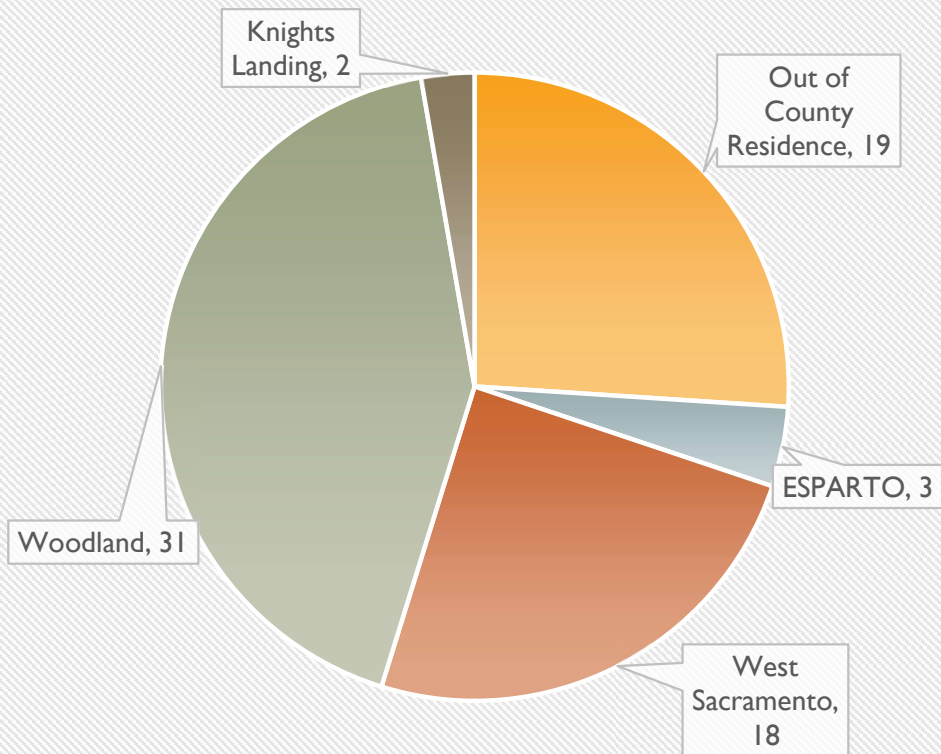
AVERAGE DAILY POPULATION AND POPULATION MAX

Average Daily Population January - July 2024

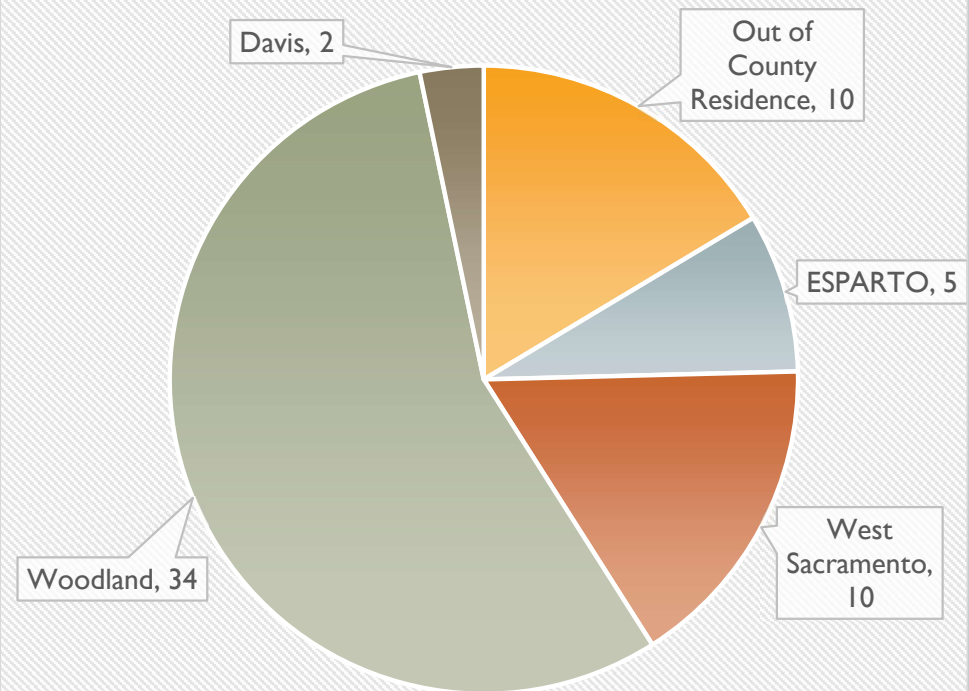

Juvenile Bookings by City January – December 2023

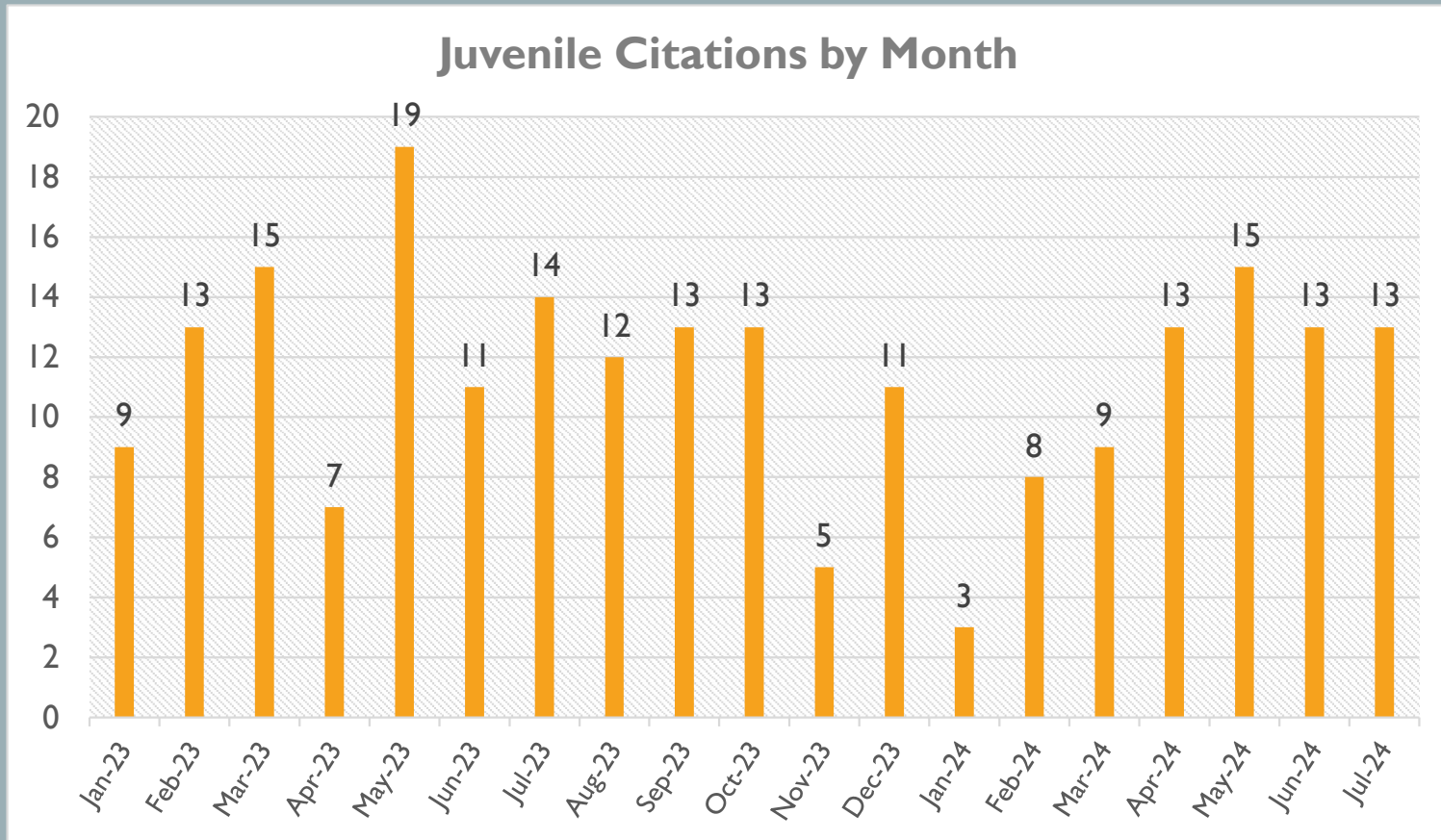


Juvenile Bookings by City January - July 2024



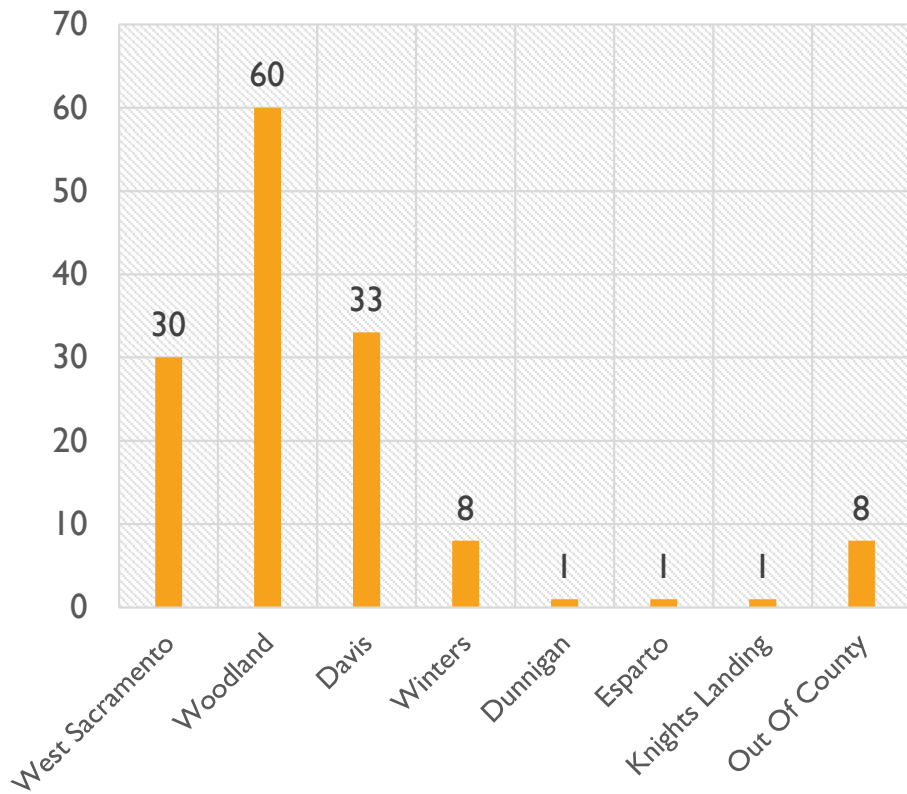

01/01/2023 – 07/31/2024

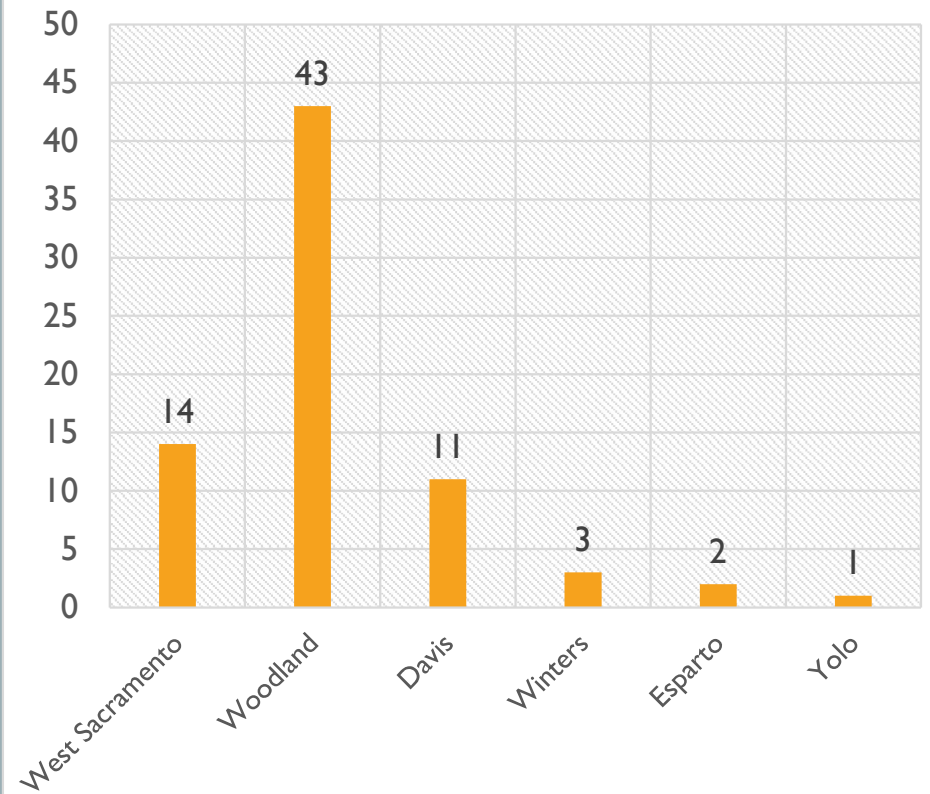

Juvenile Citations by City 2023

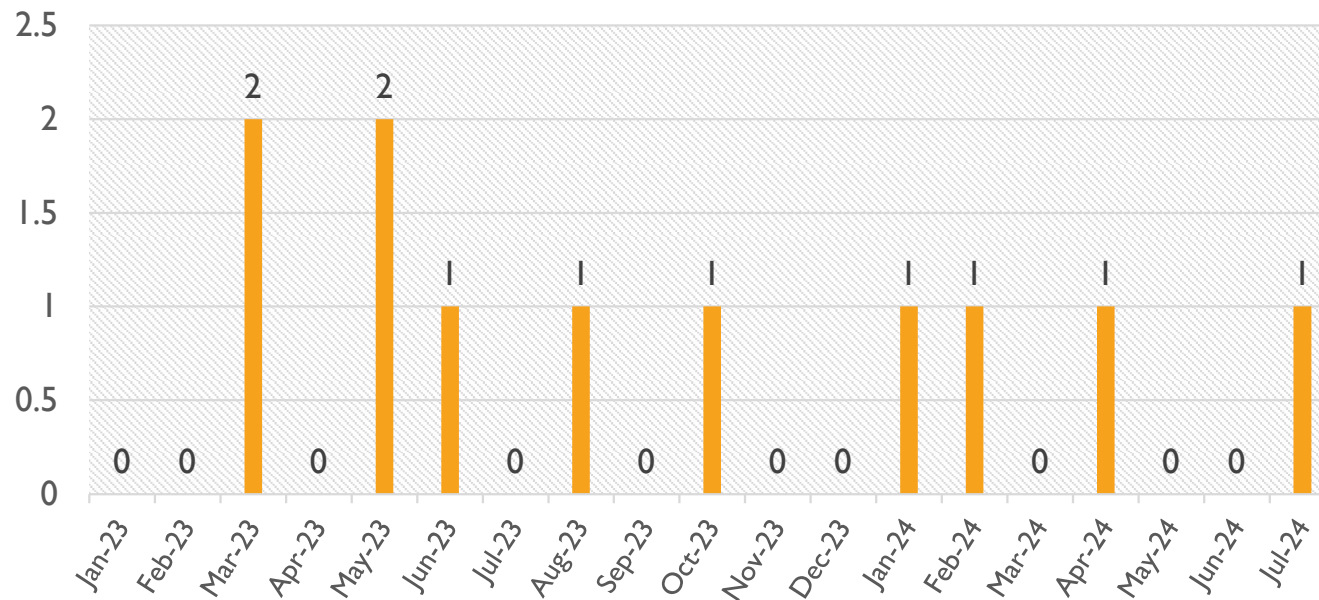


Juvenile Citations by City 2024
