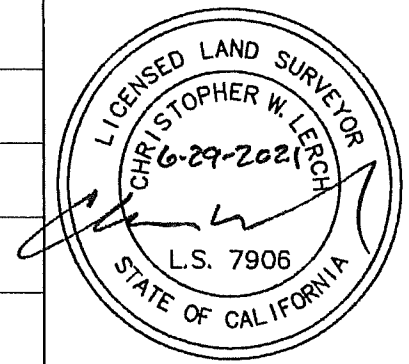

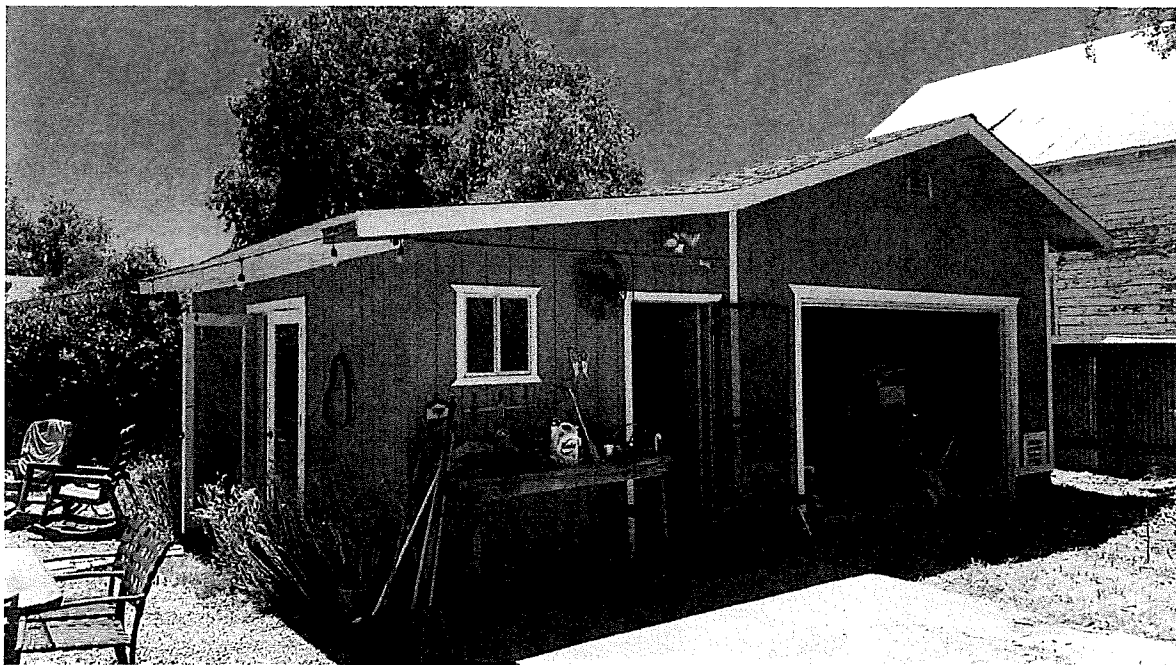


Photo One Caption **FRONT & LEFT SIDE VIEWS (TAKEN 06/23/2021)**

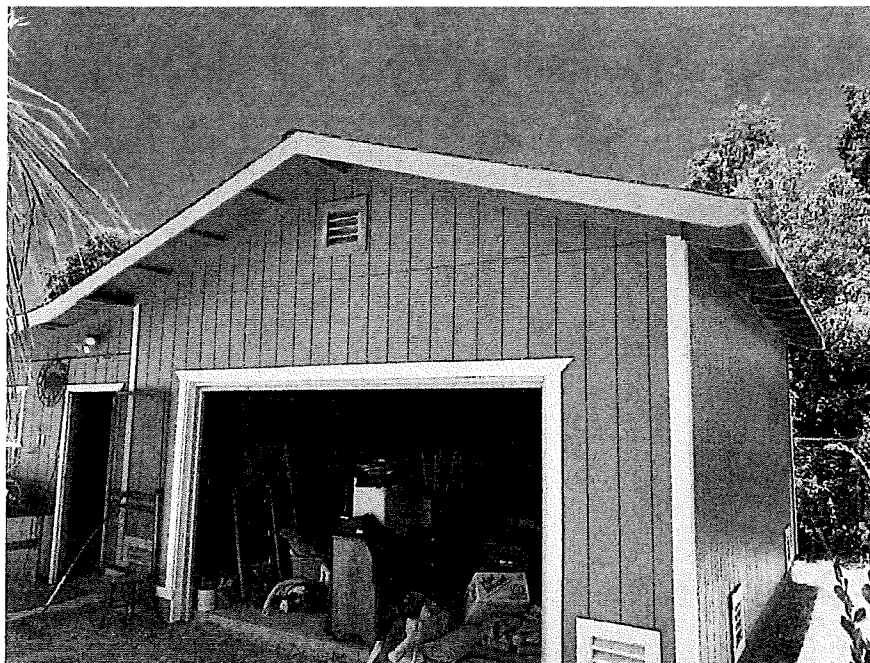


Photo Two Caption **RIGHT SIDE VIEW (TAKEN 06/23/2021)**

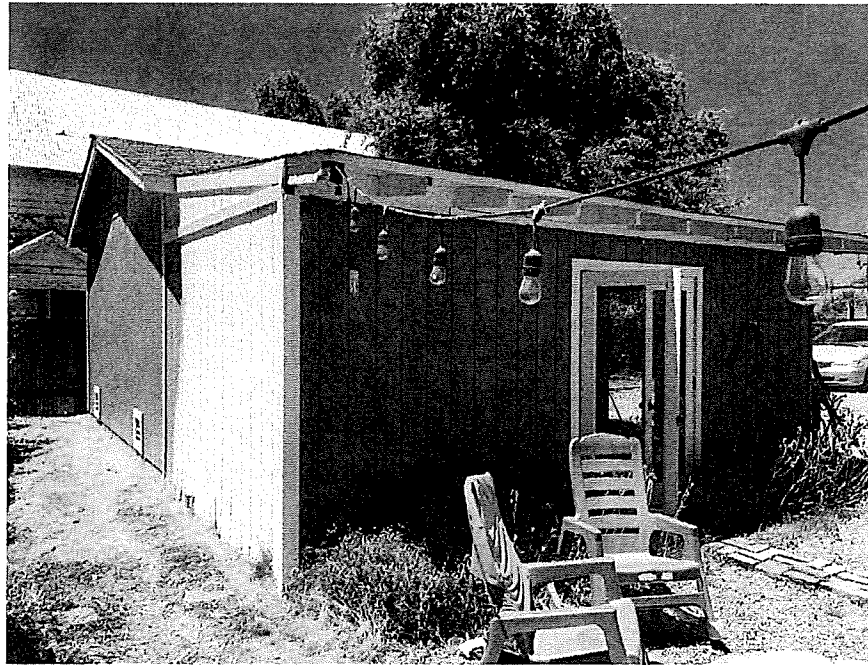
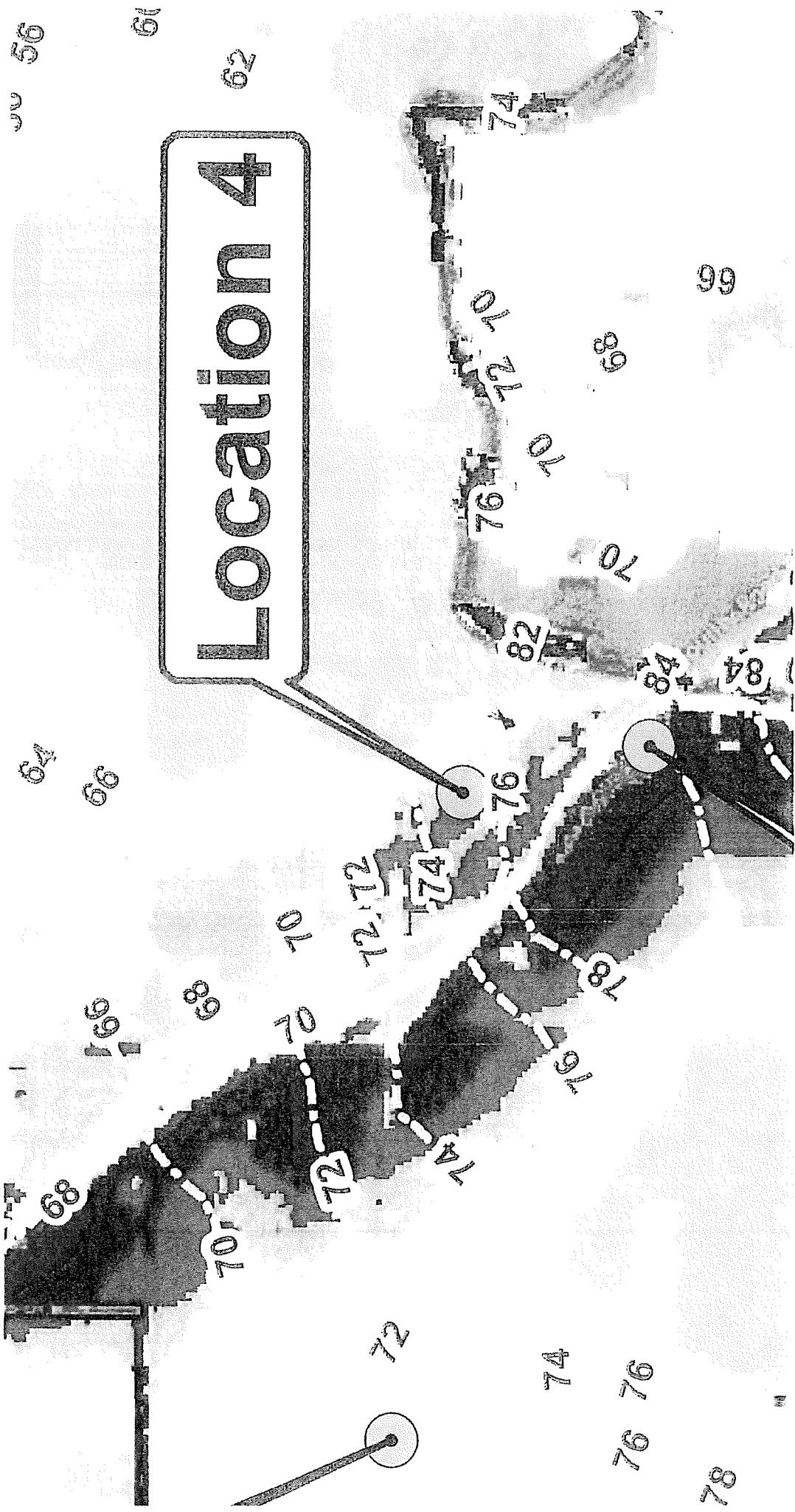


Photo One Caption **REAR VIEW (TAKEN 06/23/2021)**
