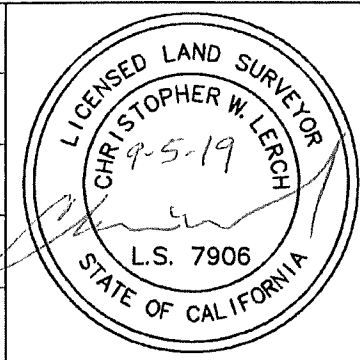

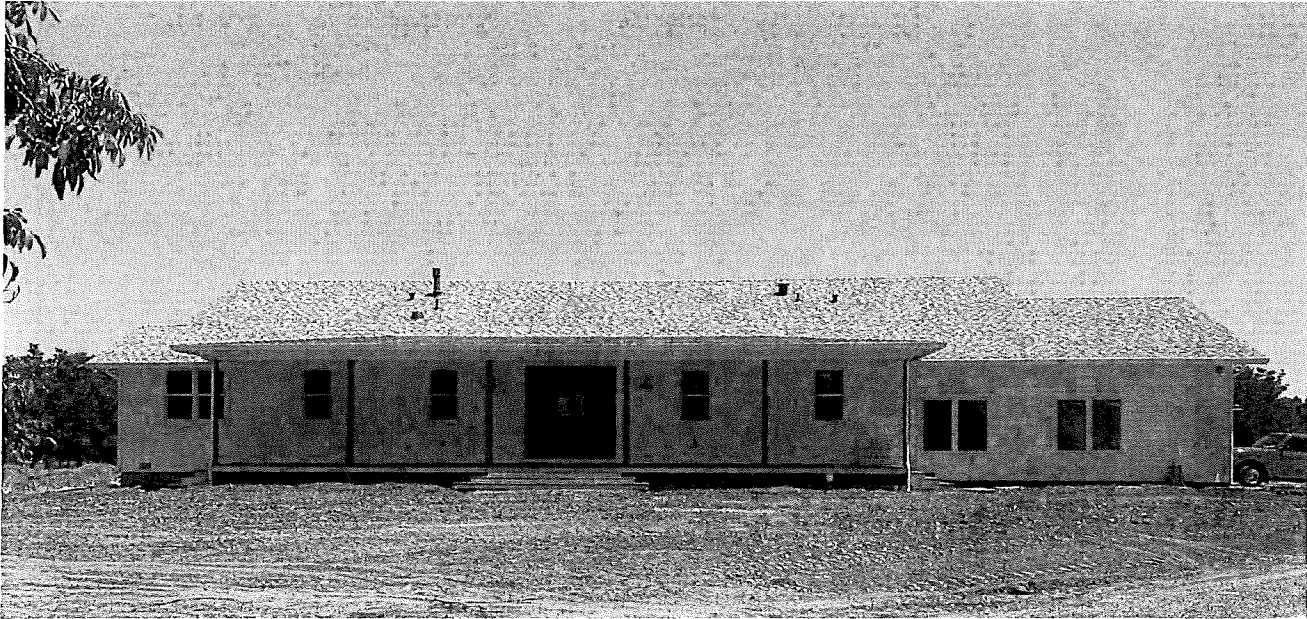


Photo One Caption **FRONT VIEW (TAKEN 07/19/2019)**

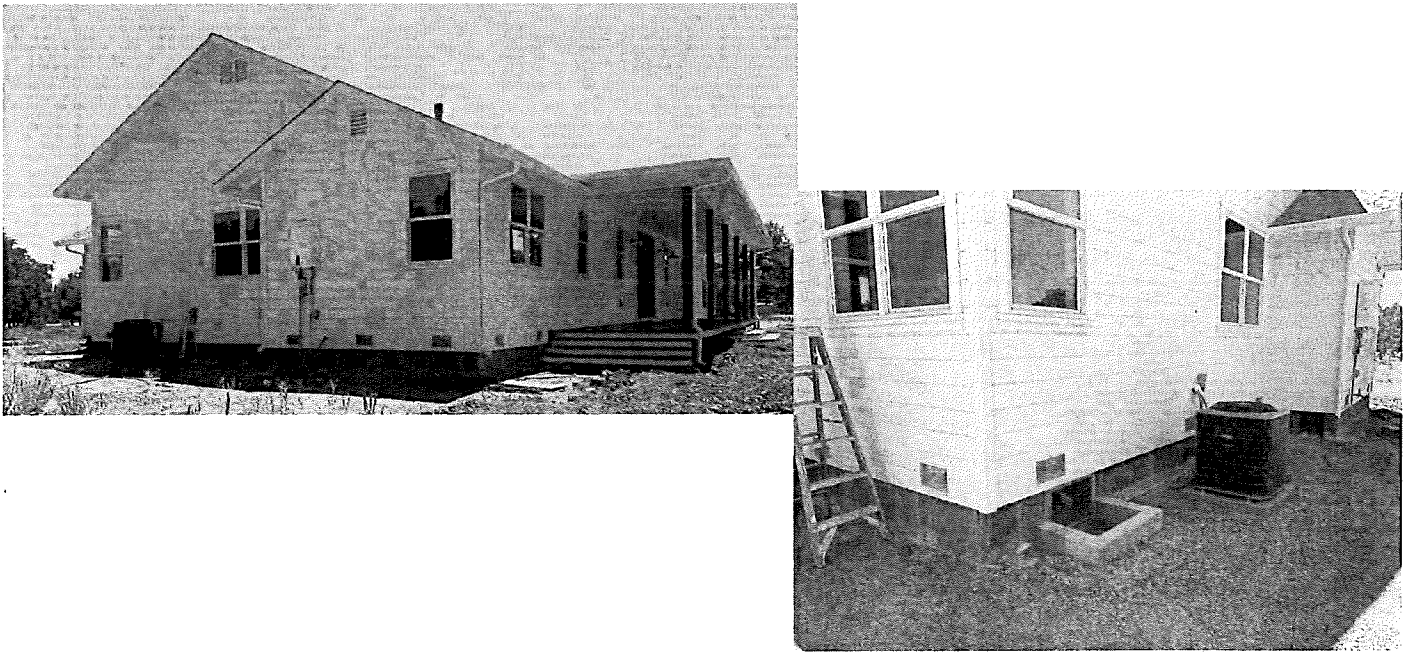
