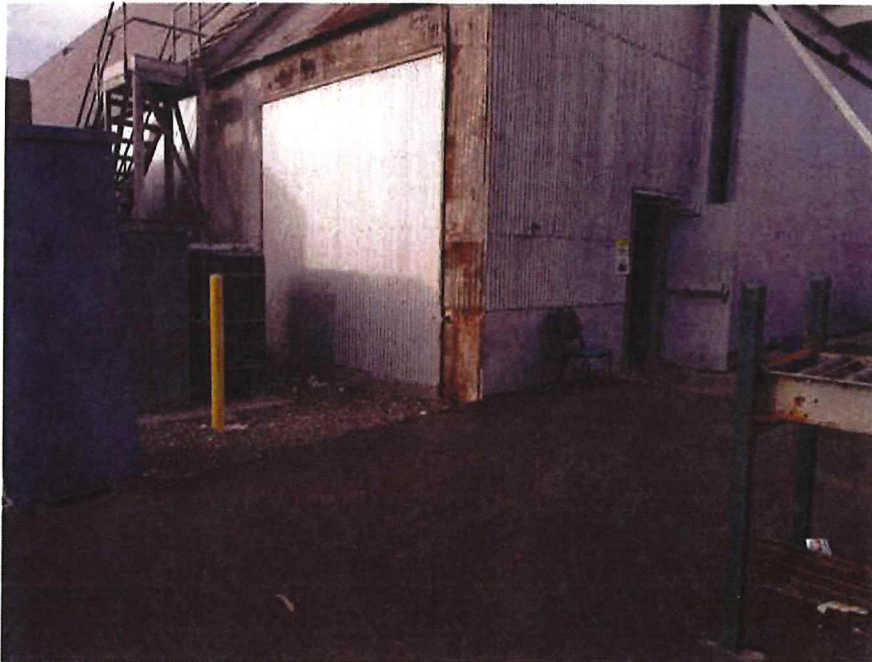

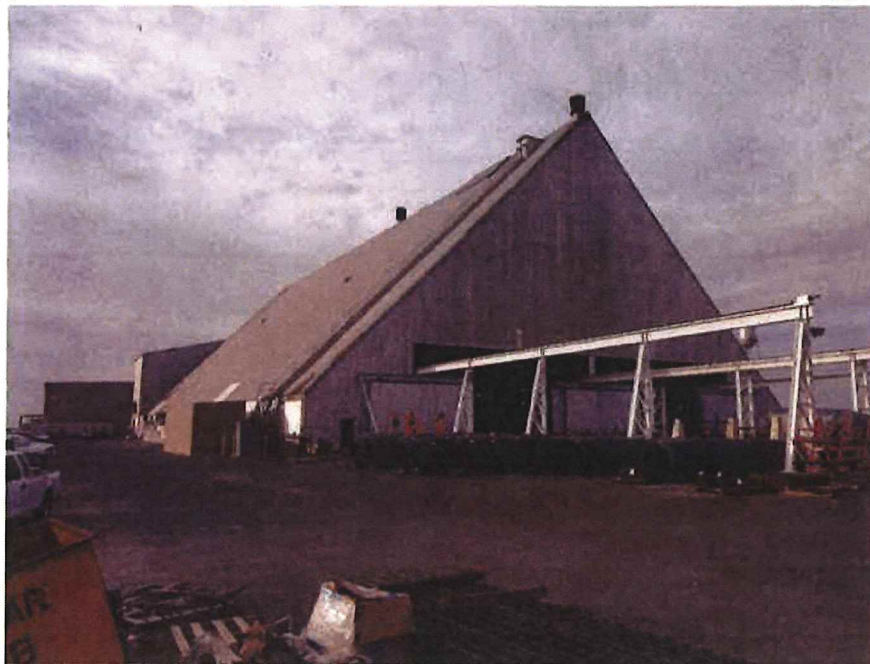


Photo One Caption **NORTH SIDE LOOKING SOUTH (TAKEN 10/24/2016)**
