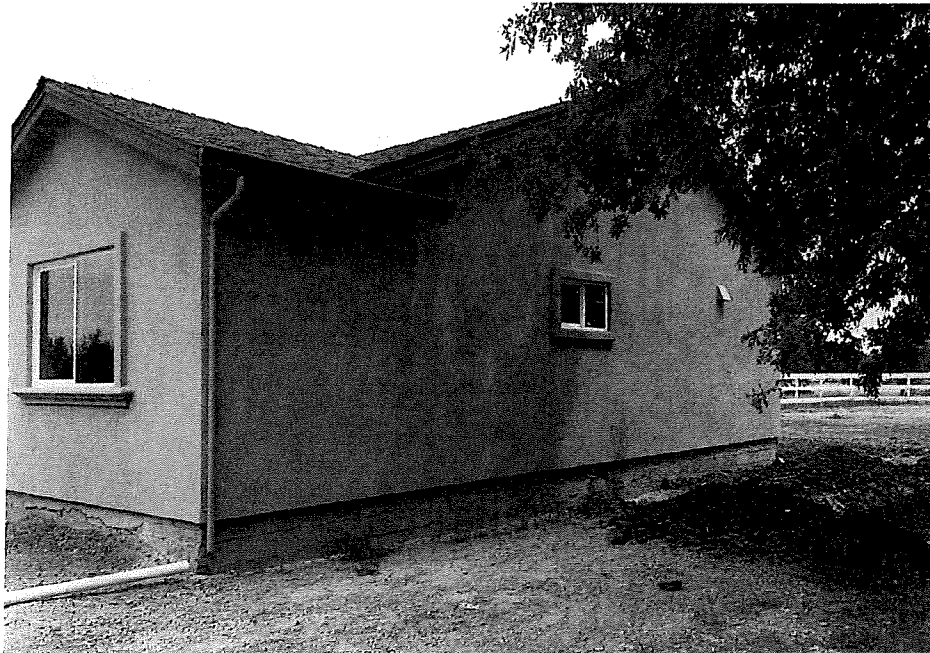

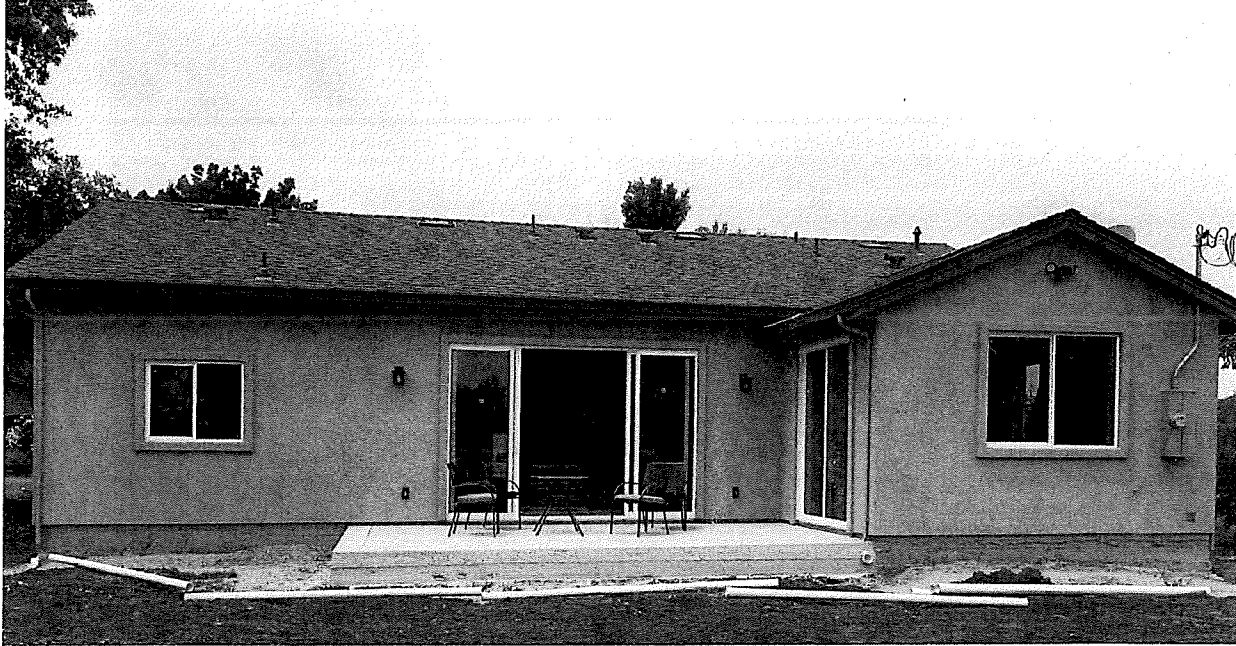


Photo One Caption **REAR VIEW (TAKEN 05/14/2019)**
