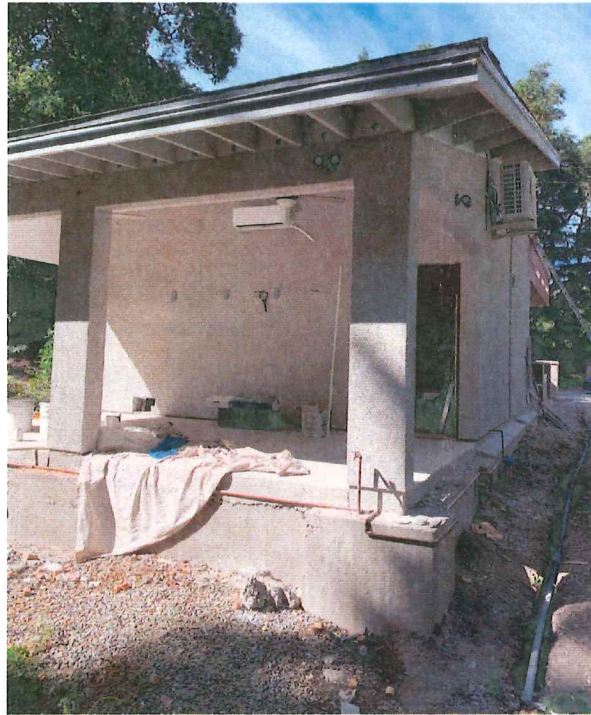


Photo One Caption **EAST & NORTH SIDE VIEWS (TAKEN 07/22/2019)**

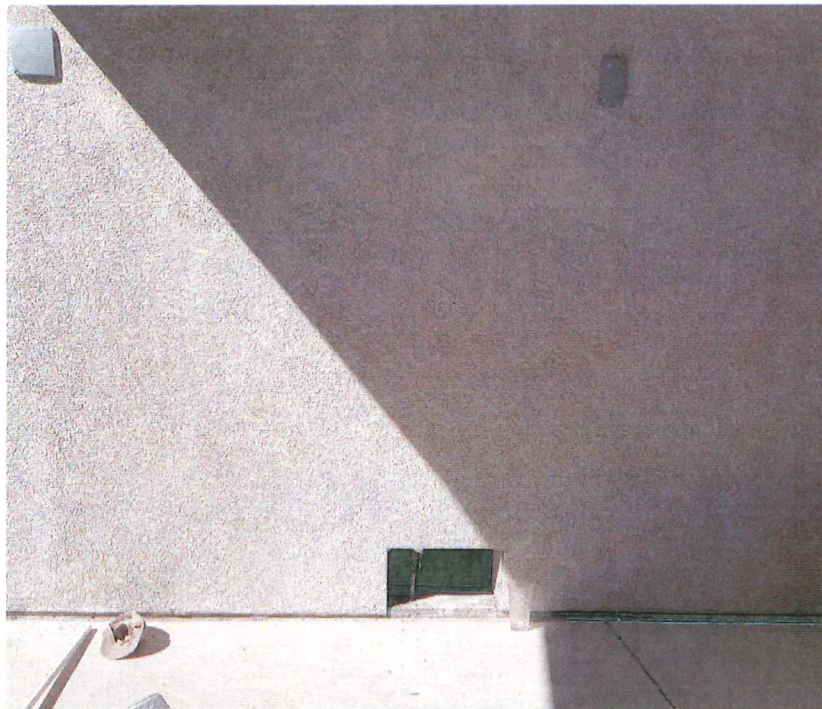
