- 4. STATE AND COUNTY UPDATE Mark Bryan, Deputy Chief Administrative Officer
  - No update today
- 5. BOARD OF SUPERVISORS UPDATE Deputy Supervisor Sheila Allen, District 4
  - Lease has been signed at Adult Day Health Center
  - County working with city on moving local food vendors to be licensed to assure food being served is safe
  - Animal Shelter-UCD signed a granted called Clinic in a Can Will support any medical needs for animals to include spay and neutering
  - Walnut Park Library is moving forward
- 6. HEALTH OFFICER UPDATE Dr. Aimee Sisson, Health Officer
  - COVID-19 levels vary across Yolo County
    - o Indoor masking recommended for all when SARS-CoV-2 levels in Wastewater are HIGH
    - Indoor masking recommended for person at high risk or who are in close contact with persons at high risk when levels are MEDIUM
    - Most national COVID indicators are decreasing

- Vaccine is best protection against severe disease, hospitalization and death
- 2024-25 COVID-19 vaccine is FDA approved
- Targets currently circulating Omicron variants
  - Pfizer and Moderna: KP.2
  - Novavax: JN.1
- Available from provider offices and retail pharmacies
- Can be given at same time as seasonal flu vaccine
- Recommended for everyone 6 months and older
- At least 2 months since last COVID vaccine
- Consider waiting 2-3 months after COVID infection before getting vaccinated
- West Nile virus continues to spread
  - Several recent cases of West Nile virus infection among Yolo County residents
  - Spread by bite of infected mosquito
  - Protect yourself against mosquito bites
    - Dawn and dusk
    - Mosquito repellent (free in County vending machines and from SYMVCD)
    - Long sleeves and pants
  - o 80% of infected people have no symptoms
  - o 20% of infected people get fever with headache, body aches, joint pains, vomiting, rash
  - o 1 in 150 infected people get severe illness impacting central nervous system
  - Can be fatal
- 3 dairy herds in Central Valley infected with H5N1
  - CDFA announced on 8/30 that cows at 3 dairies in Central Valley tested positive for avian influenza (H5N1)
  - H5 detected in Turlock wastewater on 9/4
  - No human cases of H5N1 in California at this time
  - No affected California poultry farms at this time
  - Providers should consider avian influenza in dairy workers with flu-like symptoms
  - In U.S. there have been 15 human cases of H5 since March 2024
    - 4 in dairy workers
    - 10 in poultry workers
    - 1 with no known animal exposure
  - Risk to general public remains low
- Harmful algal blooms affect Yolo County
  - o 3 recent algal blooms in Yolo County water bodies
- Please heed HAB warnings
  - CAUTION Harmful algae may be present in this water
  - o WARNING Toxins from algae in this water can harm people and kill animals
  - DANGER Toxins from algae in this water can harm people and kill animals

- 9. MCO Tax Joshua Heller, Yes on Prop 35 Campaign
  - THE PROBLEM: Our Health Care System is in Crisis
    - Californians are struggling to access health care
      - Hospitals and clinics are closing
      - Overcrowded emergency rooms
      - More than 40 hospitals have stopped offering labor & delivery services
      - Patients struggling to schedule appointments
  - Crisis is worst for CA's most vulnerable populations
    - o More than 15 million rely on Medi-Cal including more than 50% of children
    - Lack of adequate funding for Medi-Cal contributing to crisis
  - The Solution?
    - YES on Proposition 35
    - PROP 35 provides dedicated funding to improve our health care system
      - Prop 35 addresses our most urgent health care priorities by securing a dedicated, ongoing funding source – without raising taxes on individuals to protect and expand patient access care
      - Permanently extends an existing levy on health insurance that would otherwise expire in 2026
      - Establishes strong accountability provisions to prevent funds from being used for other purposes
