CCP Budget Forecast

At the May 29 meeting of the Community Corrections Partnership, the Chief Budget Official provided a verbal update to the Partnership regarding the Governor’s May Revise and its likely impacts on projected CCP funding for the 2024-25 fiscal year. Since that time, the State approved its budget, which included the following adjustments to CCP funding:

In 2021-22, the CCP adopted a percentage-based budget model which allowed the CCP to streamline its budgeting process, resulting in each department and focus area (Treatment, Innovation, Administration) receiving a percentage of base and growth revenues annually. Based on the adopted model, anticipated 2024-25 allocations for each area have been adjusted as follows:

Along with the above projections, the CCP allows each department and focus area to maintain any portion of unspent funding allocations in dedicated fund balances. At the April 8 CCP meeting, the Partnership voted to allocate an unallocated fund balance of approximately \$794,000 to all areas of the percentage-based budget model. Several departments utilized these funds to balance their 2024-25 budgets. Projected fund balances for the 2024-25 fiscal year, minus those utilized in the 2023-24 fiscal year, are reflected in the table below:

Please note, the above are projections derived from current information. Updated figures will be provided following the close of the 2023-24 fiscal year.

2024-25 CCP Adopted Budget

At the April 8 CCP meeting, the CCP approved a Treatment allocation of \$485,000 for Substance Use Disorder Treatment (broadly referred to as “Treatment”) with funding from the Treatment silo of the percentage-based budget model. At the time, this amount was believed to be sufficient to fund services in the 2024-25 fiscal year. However, at this time, staff request an increase to this allocation:

Staff request an increase of \$40,000 to the amount previously appropriated for the 2024-25 fiscal year. This increase is based on anticipated year-end expenses for the 2023-24 fiscal year. Expenses for the 2023-24 fiscal year are projected to be approximately \$509,921, an overage of \$24,921 from the approved 2023-24 allocation. Staff are also requesting approval to increase the 2023-24 allocation to \$509,921 to pay existing bills.

Increases in Treatment expenses are the result of several factors:

- Increase in clients served
- Increased cost for service

Subject: Approve revised Guidelines on the Provision of Information to the Public and Media

Background

To address the 2023-2025 CCP Strategic Plan outcome of an “increased public understanding of the criminal justice system and the work of the CPP”, during its November 14, 2022 meeting, the CCP approved convening a Public Relations Ad Hoc Subcommittee (made up of members Olson, Sullivan and Raven) to revise the CCP’s Guidelines on the Provision of Information to the Public and Media.

The intent of the guidelines, initially established on February 9, 2015 is to ensure the release of timely, accurate, comprehensive, authoritative and relevant information in the interest of sharing the good works of the CCP with the Yolo County community. The guidelines outline a process for the approval of information for release, dissemination of information, response to public or media inquiries and use of the CCP’s website.

Recommended Action

Approve revised Guideline on the Provision of Information to the Public and Media (Attachment B).

Guidelines on the Provision of Information to the Public and Media

Updated: August 12, 2024

Background: The Yolo County Community Corrections Partnership (CCP) is the governing body responsible for developing and submitting public safety realignment implementation recommendations to the Board of Supervisors to support long-term systemic reform. The CCP is interested in sharing the good works of the CCP with the Yolo County community, is committed to a culture of transparency and openness with the public and media, and it values the responsible and timely exchange of information.

Purpose and Scope: This document provides guidance on the provision of information related to the business of the CCP to the public and media. These guidelines exist to assure information released by the CCP is timely, accurate, comprehensive, authoritative and relevant. These guidelines cover information in any form provided to the public and media on behalf of or in the name of the CCP, especially information that has the potential to generate media attention, public interest or inquiry. Examples include, but are not limited to interviews, news releases and information published on the CCP website or released via social media.

Guidelines: In many circumstances, the CCP will have information to share with the public. In other circumstances, a member of the public or media may seek information from the CCP about its programs, policies, activities or recommendations. The CCP seeks to provide the widest practical and appropriate dissemination of information as follows:

- A) **Approval of Information for Release:** Information released on behalf of or in the name of the CCP shall be about the business of the CCP. Information for release will be funneled through the CCP Analyst, who will, as needed, seek guidance from the CCP Chair, County Counsel and/or the County Public Information Officer (PIO)
- B) **Dissemination of Information:** As appropriate, the CCP will disseminate information directly to the media and public concerning CCP programs, activities, policies and recommendations. The primary method of dissemination will be through news releases and social media posts disseminated via the PIO.
- C) **Response Public or Media Inquiries:** The CCP Chair is the principal point of contact for public and media inquiries related to CCP business and activities. The Chair may elect to designate another member of the CCP to respond given their expertise or familiarity with a given CCP program.
- D) **Website:** The CCP Analyst will maintain up-to-date and relevant information on the CCP's website (www.YoloCounty.org/CCP). This will include the posting of CCP meeting agendas and minutes, links to CCP news releases and maintenance of CCP-funded program information and related performance measures.

Approval of Guidelines: The CCP approved the original policy on February 9, 2015. These guidelines may be modified or amended with the approval of a majority of the CCP.

Background

The CCP endeavors to operate transparently to increase the public's understanding of the criminal justice system and the work of the CCP. As such, one strategy in the 2023-2025 Strategic Plan related to this outcome is to produce a dashboard. While Program Summaries and Annual Reports provide an annual update on CCP-funded programs, a dashboard can show the community the impact of the work of the CCP.

The dashboard would be publicly accessible via the CCP's website (www.YoloCounty.org/CCP). It was designed to provide a brief explanation of public safety realignment and context for the data displayed. It is formatted to be a static page, updated quarterly, displaying information on the realigned population and their risk to re-offend.

Recommended Action

Review and provide feedback on the draft dashboard with a focus on strengthening the public's understanding of the criminal justice system and the work of the CCP.

Yolo County Public Safety Realignment Dashboard

Public Safety Realignment

To reduce State prison overcrowding and help lower the State's incarceration costs, beginning in 2011, the Legislature transferred the responsibility for managing certain individuals sentenced for nonviolent, nonserious, and non-sexual offenses, including both incarcerated persons and probationers, from the State to counties—a change in responsibility commonly referred to as Public Safety Realignment or simply Realignment. Under Realignment, some newly sentenced persons who previously would have served their sentences in a State prison instead serve their sentences in a county jail. Senate Bill 678 (chaptered on October 11, 2009) established the program to reduce the percentage of adult probationers sent to prison for a probation failure. This bill added Penal Code section 1230, which established the Community Corrections Partnership (CCP) as an advisory body to Probation.

Mandatory Supervision (Penal Code Section 1170(h)(5)(b))

Mandatory Supervision was created by the Public Safety Realignment Act of 2011 (AB 109). The Legislature's intent was to promote successful return to the community by sentencing specific felony convictions to local "prison" sentences at the county jails, instead of sentencing them to state prison sentences. To be eligible for a local "prison" sentence, the offense at hand cannot be serious as described in Penal Code Section 1192.7(c), or violent as described in Penal Code Section 667.5(c), or any felony conviction that would require the offender to register as a sex offender, pursuant to Penal Code Section 290.

Additionally, the Court may find that in the interests of justice, a portion of a defendant's sentenced term may be suspended and shall be known as Mandatory Supervision and shall commence upon release from physical custody. During the period of Mandatory Supervision, the defendant shall be supervised by the county probation officer in accordance with the terms, conditions, and procedures generally applicable to persons placed on probation for the remaining unserved portion of the sentence imposed by the court. The period of supervision shall be mandatory and may not be earlier terminated, except by court order.

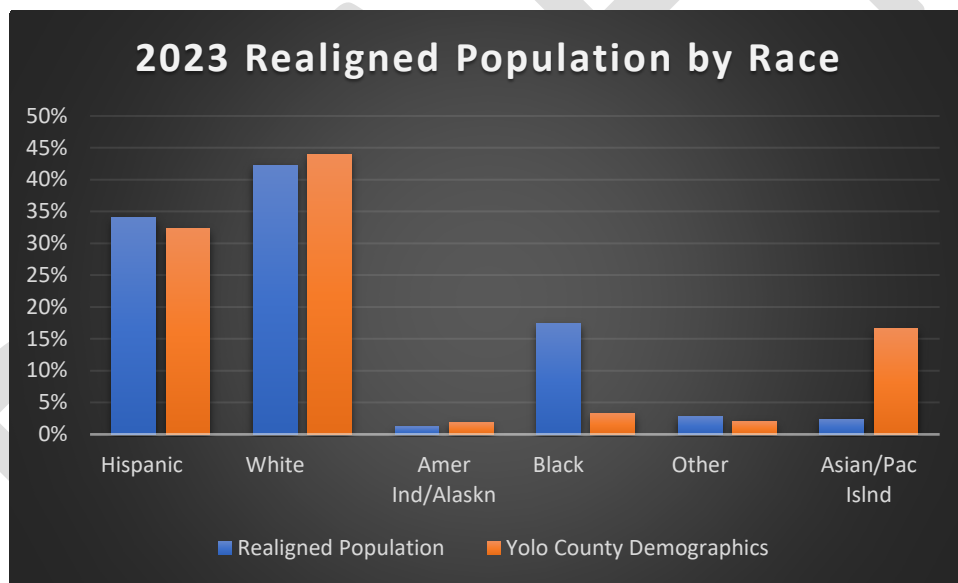
PRCS (Penal Code Section 3450)

The Legislature's intent for the Post Release Community Supervision Act of 2011, was to reinvest in criminal justice resources by supporting local community corrections programs and evidence-based practices that improve public safety by returning offenders who were sentenced to state prison to local probation supervision. To be eligible for PRCS, offenders cannot have been sentenced to state prison for their most recent term for any offense that is serious as

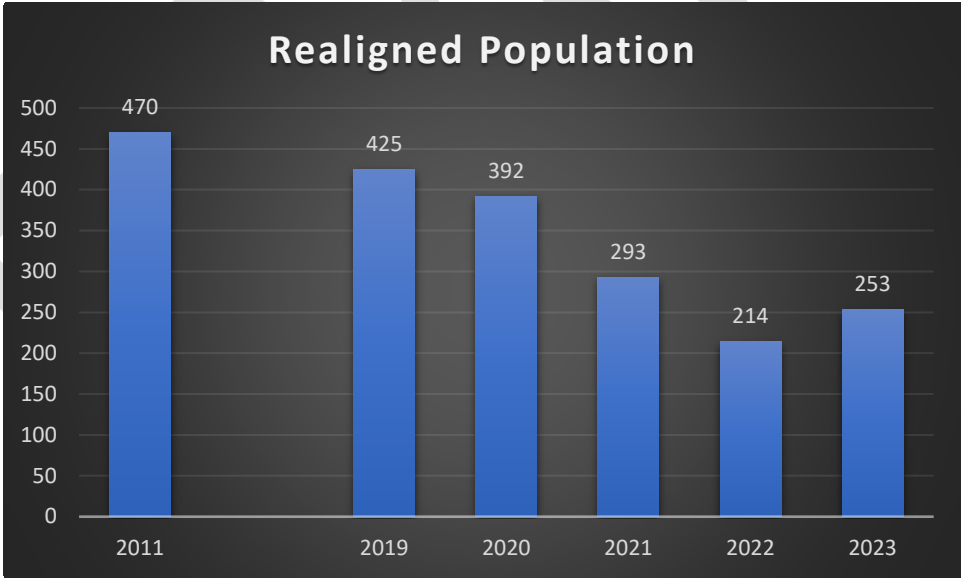
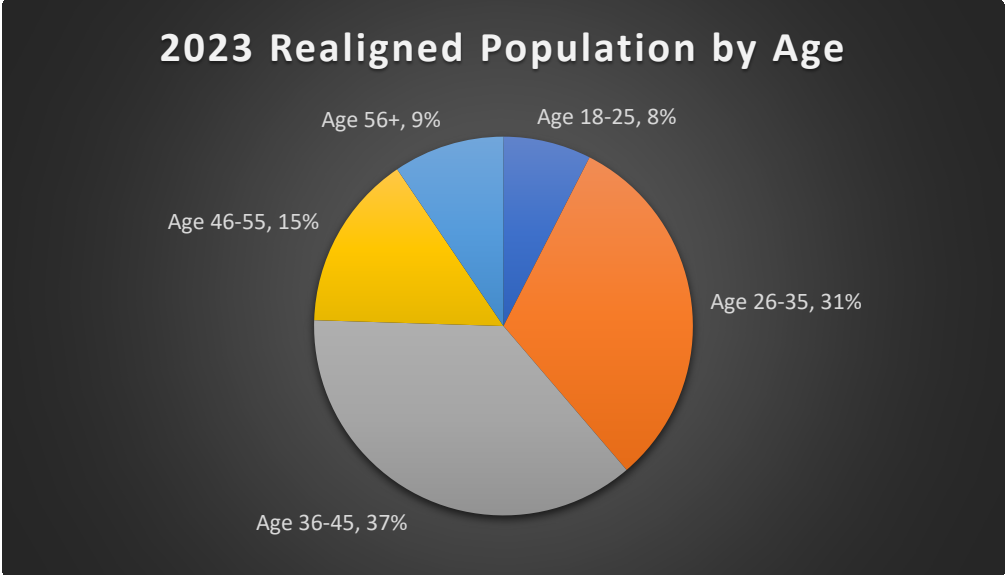
described in Penal Code Section 1192.7(c), or violent as described in Penal Code Section 667.5(c), or any felony conviction that would require the offender to register as a sex offender, pursuant to Penal Code Section 290.

Offenders who do not meet the above criteria, are returned to state parole for supervision. All PRCS eligible offenders shall be supervised by the county probation officer in accordance with the terms, conditions, and procedures generally applicable to persons placed on probation for a similar offense.

Any person who has been on PRCS supervision continuously for one year with no violations of his or her conditions of supervision that result in a custodial sanction shall be discharged from supervision within 30 days. No person shall remain under PRCS supervision or in custody pursuant to this title on or after three years from the date of the person's initial entry onto PRCS community supervision.

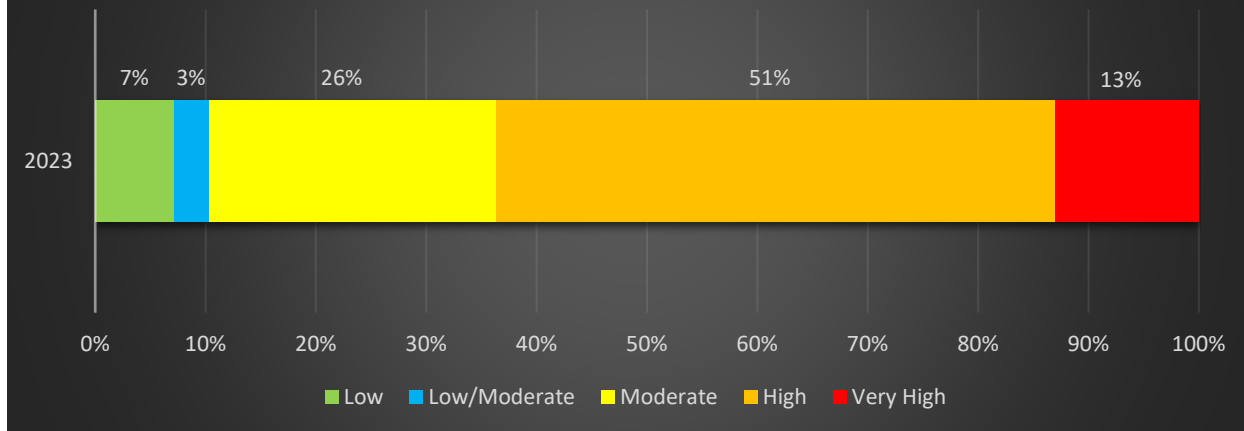


In 2023, Yolo County had a total population of 220,544. In that same year, the Probation Department had 976 adults on probation (0.4% of the total population), 268 of which were realigned individuals (0.1% of the total population). With the exception of Black and Asian/Pacific Islander, the realigned population is similar to the greater Yolo County population based on race.



Upon implementation of AB 109 in 2011, Probation had 470 individuals that were granted 1170 or PRCS probationary status. In the last 5 years, there has been a net decline in the total number of individuals that fall under realignment.

2023 Realigned Population Risk to Re-Offend



Part of supervising the realigned population is understanding their risk to re-offend once released into the community. The Yolo County Probation Department relies on the Ohio Risk Assessment System (ORAS) to measure multiple variables that indicate whether or not an individual on probation is likely to reoffend.

Note: while this is a valuable tool, it is not an indicator of public safety based on the level of crimes committed. For example, there are probationers whose risk score is high, but the crime they have committed may be less damaging to the community, i.e., theft. Conversely, there are probationers whose risk score is low, but the crime they have committed may be more serious, i.e., murder.
