  - a) **Motion** to approve minutes of 12/16/08 by J. Hulsman, second by W. Belshaw, all approved, none opposed.

  - c) M. Jordan attended water district meetings. Asking community to pay additional \$100K for more piping unforeseen by engineer (state requirement for 1-1/2" at meter instead of <sup>3</sup>/<sub>4</sub>, and costly recent repair).
  - d) G. Moris ACTM funds remaining are going to pay for County legal expenses.
  - e) M. Jordan supervisor Rexroad mentioned he likes 100' ag buffers and have the farmers maintain them (instead of subdivision).

### DMX Commercial zone

8) Eric Parfrey summarized Planning Commission results – 6-1 vote to allow single family detached if it was at least 10 units/net acre.

a) M. Jordan – why do they feel it is important to have single family residential?

b) Leroy, there was a feeling that the commercial space was more than what was needed.

c) Eric – Board of Supervisors asked him to work with SACOG staff on massing studies.d) May go to Board of Supervisors on 2/24 at the earliest.

e) G. Moris – request graphic added to show residential potential compared to DMX.

f) G. Moris – do we need to focus on the single family detached leading to subdivided parcels?

g) M. Jordan – suggest draft a letter to send to the supervisors for review at next meeting.

### 8) ECAC membership

# 9) Esparto Street Lights.

- b) Water Board made and agreement with PG&E to collect \$1.50 per resident monthly to pay for street lights. Currently pay \$1.73 – no answers as to why lights have not been replaced.
- c) Some locals have purchased lights or tried to get them fixed.

### 10) Planning Commission Citizen's Advisory procedures sub-committee

- a) Jeb Burton, Jeff Merwin, and Leroy Bertolero will represent the Planning Commission on this group. Eric will rep the staff.
- b) 3 meetings between now and summer 2.5 hours each, to go through guidelines.
- c) Representative from ECAC needed.
- d) Leroy hopes to formally get approval to form the sub-committee from Mike McGowan shortly.
- e) M. Jordan and J. Hulsman mentioned criticism of ECAC in Leroy's letter came from unfair comments made by Chamber rep. The developers want to cut down application time. Eric mentioned other advisory committees have had their issues.
