RECOMMENDED ACTION

Receive and file an update on Request For Proposal (RFP) for management of Wild Wings Golf Course.

STRATEGIC PLAN GOALS

This action is consistent with the goal of ensuring a financially sustainable county government by ensuring that activities related to the acquisition, operation, management, and improvement of the golf course are fully funded by the special tax.

FISCAL IMPACT

Based on the proforma KemperSports submitted in response to the RFP, the projected fiscal impact to the homeowners at Wild Wings could result in lower Special Tax rates of a minimum of \$417 per household in the first full fiscal year (\$417 less than the \$1,700 maximum), if Measure O (Special Tax) passes on March 10, 2009 (Attachment A).

REASON FOR RECOMMENDED ACTIONS

To provide the governing board a progress report on the directives given by the Board on October 21, 2008.

BACKGROUND

CSA staff has completed the following:

Prop 218 election for fees for increased water and sewer costs and basic maintenance of Α. the golf course property as needed to insure proper dispersal of treated water; the Prop 218 fee will only go into effect if Measure O does not pass. If the new fees are put into effect, residential water and sewer fees will increase by up to \$999 per year.

- B. Scheduled election for residents to vote on a Special Tax (Measure O) for acquisition, operation, and management of the golf course property and related capital improvements; Measure O adds a maximum of \$1,700 to the fees, assessments, and taxes currently paid by Wild Wings residents.
- C. Completed negotiation with Wild Wings LLC for CSA acquisition of the golf course, pending the passage of Measure O.
- D. The Wild Wings CSA Advisory Committee established an RFP subcommittee and released an RFP for the maintenance and operations of the Wild Wings Golf Course on December 17, 2009, and received two responsive bidders. The subcommittee interviewed and selected KemperSports (currently manages 26 public golf courses), to manage the Wild Wings Golf Course (subject to Governing Board approval).

On September 4, 2008, Wild Wings LLC informed Yolo County staff that after several unsuccessful attempts to sell the Wild Wings Golf Course, it would close the Golf Course, effective September 15, 2008. The date was extended to December 4, 2008, after the CSA Governing Board agreed to allow residents to vote on a Special Tax to acquire the Course. The CSA Governing Board agreed to put forward the Special Tax based on the recommendation of the Wild Wings Advisory Committee, with support from the Wild Wings Home Owners Association (HOA), along with a group of homeowners calling themselves "Save the Wild Wings Golf Course" (SWWG) – (Attachment B).

The CSA Advisory Committee's October 7, 2008 meeting is one of many public meetings residents of Wild Wings have had, to express their opinion on the acquisition of the golf course (Attachment C). Most recently, County Counsel staff, LAFCO, CSA staff, and KemperSports were invited to a meeting hosted by SWWG to discuss Measure O. During the meeting, KemperSports proforma was distributed (Attachment D), and they fielded questions regarding their proposal to manage the golf course. Residents asked the following questions of KemperSports:

- A. Ability to manage a course with tough soil?
- B. Was their projections to break even in year #3 too optimistic?
- C. Residents want discounts for course and amenities?
- D. What is their history on non golf course activities for residents of Wild Wings?
- E. Community outreach?
- F. Responsibility and training employees that serve alcohol?
- G. Access to course for non golfers?
- H. How they planned to increase food and beverage offerings?
- I. Protection against annual losses if KemperSports projects fall short?
- J. Does Measure O require the property to be a golf course forever?

KemperSports Regional Manager fielded the questions, and CSA staff are seeking to address some of these concerns and issues in the management agreement that is currently under negotiation. At the meeting, the RFP committee also presented information comparing the potential cost of Measure O (based on the Projections of KemperSports) to the recent Prop 218 fee increases approved December 16, 2008 (Attachment E).

Staff expect to return on March 10, 2009, with a negotiated management agreement with KemperSports for the management of the Wild Wings Golf Course in the event it is acquired by the Wild Wings County Service Area (CSA). This report is an update for the Governing Board on staff's progress on the directive given by the Board at its October 21, 2008 meeting, whereas the Governing Board approved staff's recommendation to:

Direct CSA staff to work with the Wild Wings Advisory Board and Wild Wings CSA rate payers to:

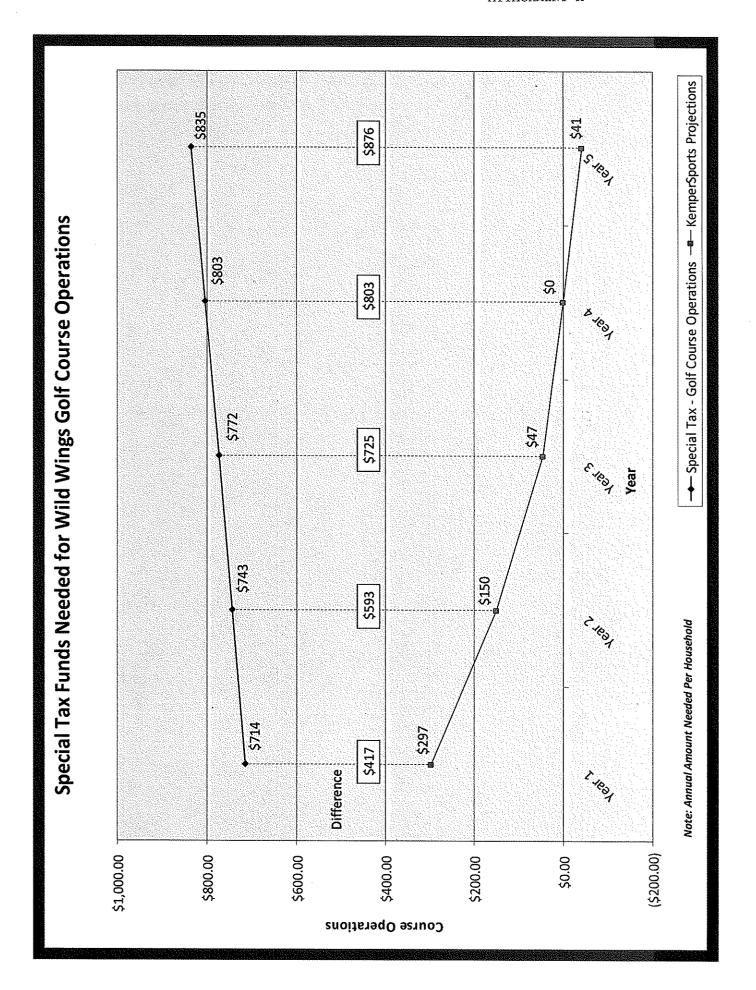
- A. develop a Request for Proposal (RFP)/Request for Qualifications (RFQ) for the operations and maintenance of the Wild Wings Golf Course on behalf of the CSA;
- B. review the existing capacity of the water and sewer system, and investigate the feasibility of allowing additional customers to hookup to the water and sewer system to lower the overall cost to the system users (recommended by the Advisory Committee on September 15, 2008); and,
- C. return to the Wild Wings CSA Governing Board with results and recommendations no later than December 16, 2008.

Dear Mr. Zraick,

The Wild Wings HOA, the Save Wild Wings Group (SWWG), the County and the Community Service Area (CSA) have met on several occasions this week in order to seek consensus on a proposed plan of action regarding ownership and ongoing operation of the Wild Wings Golf Course.

In your prior correspondence to the HOA and the County, you offered either of them ownership of the course together with all associated amenities and equipment for a \$1 fee.

It has only recently been acknowledged that, after serious formal discussion with and amongst both parties, neither the County nor the HOA is prepared to accept this offer. However, after further investigation and discussion we have concluded that our Community Service Area should be the new owner. Of course, this offer will be subject to approval by both the CSA and the Board of Supervisors. We are prepared to move forward to that end based upon the following:

1. The SWWG, will petition and make substantive recommendations to the CSA at their next noticed meeting opportunity, in the week of September 29, 2008, to develop an acquisition and implementation plan. immediately. This will be subject to the legal process and timeframe requirements Proposition 218, but we can assure you that all due haste will be made to achieve these goals within the shortest time reasonably possible. This could likely be accomplished within eight to twelve weeks.

- 2. The terms and conditions of such an acquisition would be as follows:
 - A. The purchase price will be \$1.
 - B. The purchase price will include all equipment and improvements.
 - -C. The title to the property at the close of escrow shall be free of all liens, delinquent taxes, assessments and fees and subject to only those title exceptions agreeable to buyer.
 - D. Non-delinquent taxes and fees due but not yet paid shall be prorated as of the close of escrow.
 - E. Within 5 days from opening escrow, the Owner shall provide the Buyer a due diligence package, including but not limited to all maps, surveys, reports, contracts, inventory lists, and maintenance records.
 - F. Due to public health and safety concerns and in the spirit of a collaborative solution, the Owner shall maintain the current course condition through the escrow period.
 - G. The Close of Escrow shall occur the earlier of 5 business days after the expiration of the Proposition 218 appeal period or January 15, 2009. In the event the Buyer is working with diligence and in good faith and the close of escrow needs to be delayed due to circumstances beyond its control, the Seller shall grant the buyer a one time 60-day extension.

Our commitment to you making this acquisition a reality is strong and clear. We have been working with all the stakeholders and our consensus is to move forward on an aggressive timetable allowable given some procedural constraints and concurrence with governing authorities. Yolo County Supervisor Duane Chamberlain will be giving an update to the Yolo County Board of Supervisors at the next meeting on Tuesday. September 30, 2008, and we hope it would include a positive response to this letter.

We trust you will promptly and diligently contemplate our offer and provide us with an expeditious response and opportunity to achieve a mutually beneficial resolution.
