County Housing

RECOMMENDED ACTION:

That the Board of Commissioners Approve the Resolution Adopting the YCH Risk Control Policy Statement.

BACKGROUND / DISCUSSION

Yolo County Housing makes the safety and well being of their residents and employees a priority. Through systems, processes, and methods, YCH is able to lower risks and control losses which may threaten the health and well being of Yolo County Housing and those it serves and employs.

The Housing Authority Insurance Group (HAIG) Risk Control Work Plan provides YCH with the systems, processes and methods which will result in improving risk management and in reducing loss and, as a result, reduce insurance premiums. Over the last two years, YCH has implemented several risk control procedures which have resulted in increased protection and reduced risk exposure for the agency.

Over the last five years, YCH has participated on the CHARMA Risk Control Committee which adopts a risk control work plan annually for the CHARMA organization.

The Risk Control policy statement outlines the YCH's commitment to safety. The proposed statement is:

The safety and well being of the residents, employees and volunteers of Yolo County Housing are of the utmost importance. It is also important for Yolo County Housing to safeguard its assets. Proper procedures must be established in order to ensure that the highest level of safety is provided for all. It is the intention of Yolo County Housing to abide by all applicable laws and regulations which govern the health and safety of the tenants, visitors, employees, volunteers, resources, and property.
