on an A-1 zoned parcel, as well as operate an onsite farm stand, conduct farm tours, provide spinning, weaving, and shearing classes, etc. The parcel is approximately two miles south of Esparto off County Road 87B (Patricia and Jonathan Meade). The applicant proposes to build a 1,000± square foot, one-story straw bale house that incorporates passive solar design, a grid-tied solar PV system, and other sustainable building methods. They also own the adjacent parcel - which is entirely agricultural with no developed home site – they would prefer to place a third home within the existing developed footprint. Current uses on the property include row crops, navel oranges, wildlife habitat, honey bees, and alpacas raised for fiber. Farm-related activities take place outdoors by appointment only.

- 11.8:15 Recommendation on a pre-application request only for a Tentative Parcel Map at the southeast quadrant of SR 16/CR 86A (Deterding) to divide approximately 2.0 acres into two parcels of 1.07 acre and 0.92 acre. The applicant previously received Site Plan Review approval by Yolo County on March 13, 2007, to construct a gas station/mini-mart on the western parcel, uses that are allowed "by right" in the M-1 PD zone district. The Tentative Parcel Map would divide the property so that the gas station could be constructed on one parcel and other industrial uses could be located on the adjacent eastern parcel. The site would be served by water and sewer provided by Esparto Community Services District via an easement across the school district property.
- 12.8:30 Proposed Alcoholic Beverage Control ("ABC") Ordinance and amendments to the Yolo County Code. The proposed ordinance would provide a set of procedures for the review and approval/denial for the sale of alcohol or alcoholic beverage licensing, provide the county with better control and enforcement authority over alcohol sales, and would amend the Yolo County Code regarding alcoholic beverage sales within the unincorporated areas of the county. A Negative Declaration has been prepared for this project.
