Subject: Receive consolidation status of Reclamation Districts 537, 811 and 900 in West Sacramento

### **Recommended Action**

Receive information on the status of Reclamation Districts 537, 811 and 900 for consolidation.

## **Fiscal Impact**

None, staff has provided in-house expertise to this project. At some point there may be minimal recording fee costs if the consolidation is approved.

## **Reason for Recommended Action**

Upon completion of the West Sacramento Sphere of Influence the Yolo LAFCO authorized staff to proceed on initiating a change of organization including Reclamation Districts 537, 811 and 900.

## **Background**

In both the Yolo County Water District Sphere of Influence Study and the City of West Sacramento Sphere of Influence issues with Reclamation District 811 are identified. Primarily the area formerly known as Bryte, the reclamation district is basically inactive, but levee maintenance and reclamation services are still required for the area.

Staff has been in contact with both Reclamation Districts 537 and 900 concerning possible approaches to consolidation. At this juncture, it appears consolidating RD 811 with 537 is the action to pursue. RD 537, immediately adjacent to RD 811 on the west, is the entity currently providing the reclamation services in the RD 811 area.

The Executive Officer has been in contact with Kyle Lang, the general manager of RD 537. He is currently organizing a meeting of his Board of Trustees to discuss the consolidation with RD 811. We hope this meeting will occur some time in May.






