**NOTICE IS HEREBY GIVEN** that the Yolo County LAFCO has set Monday, June 22, 2009, at 9:00 a.m. as the date and time to hold a Public Hearing on the Yolo Port District Municipal Service Review and Sphere of Influence Study in the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, California.

The hearing will hold discussions, receive testimony, and consider action on the final Municipal Service Review (MSR) and Sphere of Influence (SOI) studies for the Yolo Port District. The MSR is a document used to establish the service information for the review, analysis and recommendations of the fire district. The SOI is a guidance document used by the Yolo LAFCO to help project the direction, type and timing of boundary changes for the district. The Commission will also consider adoption of a General Exemption of Environmental Review as allowed by the California Environmental Quality Act. The Yolo Port District covers approximately 65,000 acres of Yolo County.

The final MSR and SOI documents will be available for review at the LAFCO office, 625 Court Street, Suite 107, Woodland, California, five days prior to the hearing date. The agenda will be posted at least five days prior to the noticed hearing at the above address and on line at [www.yololafco.org](http://www.yololafco.org) . All interested parties are invited to attend the public hearing.
