Agenda Item No. 4.04 Executive Director Comments

Received comments from the Executive Director, Lisa Baker, who addressed the Board of Commissioners and provided an update on the following issues:

- TANA construction is complete except for final approval from UCD.
- Meadowlark Interior and front yard improvements are complete, with rear yard improvements beginning next week consisting of non-poisonous plantings, mulch, drip irrigation, concrete pad and retractable awning. Preliminary meetings with Turning Point and ADMH determined that YCH will be designated the property manager of this property, with Turning Point being the social services manager in charge of tenant selection and removals from home. Still negotiating MOU's, which will be brought back to the Board.
- Trininty property construction work is almost complete and it is expected to be complete by the third week in June.
- For the Davis Solar, quite a few carports have been finished and due to the very low quote they received, they will have additional funding to put some items back in and seek an additional bid for that work, with a contract extension until 2010 with the City of Davis to use the balance of those funds.
- Finished a VMS (Verification Management System) audit by the Department of Housing and Urban Development, which verifies their numbers and is a basis by which they receive funding. The YCH fared pretty well there were a few things they needed to tighten up, however, the auditors had some nice things to say about their finance department.
- Sponsoring training for their workforce by bringing in trainers, rather than traveling to training sessions. Also offering this training to other housing agencies, including HUD, so far this program is working out quite well, with the positive feedback they have received.
- Annual planning retreat for staff is being coordinated for the end of June. One of the big topics of discussion will be the 60th anniversary yearlong celebration because 2010 marks the 60th anniversary of Yolo County Housing. They would perhaps like a recognition event for all of the partners who make their existence possible.
- They are also in the climate registry and are the first housing authority and first affordable housing developer in it. They are getting ready to upload their numbers.
- Providing new home for the Woodland Youth Coalition Interagency meetings, since they lost their location at Friday Night Live. This program provides activities and alternatives to gangs for Woodland youth.
- Spoke of the tour and those that went thought it was informative.
- City of Davis did license exempt daycare classes for Woodland and Winters properties,

providing training to some households on how to do daycare from their homes without a state daycare license. YCH extends special thanks to the City of Davis for their ongoing support.

- Provided presentation to the Wayfarer about their programs.
- They have purchased all the furniture and household items for the Trinity and Meadowlark properties by the deadline of May 31st.

Agenda Item No. 4.05 Board of Commissioners Comments

Received comments from the Board of Commissioners. Commissioner Provenza thanked the Executive Director for her hard work on preparing a balanced budget. Commissioner Toney commented that she attended both tours and enjoyed them and encouraged others to take tours to see the improvements to the properties that have been done. Both Commissioners McGowan and Chamberlain echoed Commissioner Provenza's comments and acknowledged a job well done. Commissioner Thomson inquired about touring the TANA property at the July 9th meeting, and the Executive Director will work on the logistics to make that happen.
